RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, in 2015, Governor Brown enacted the California Racial Mascots Act, which prohibited all public schools from using the term "Redskins" for school or athletic team names, mascots, or nicknames; and

WHEREAS, despite the passing of the California Racial Mascots Act, more than 100 schools in California continue to use other Native American names or terms as their school or athletic team name, mascot, or nickname; and

WHEREAS, indigenous people have advocated against the use of Native American terms as athletic team names, trademarks, and branding, as well as stereotypical product imagery; and

WHEREAS, the use of Native mascots dehumanizes indigenous people by employing disparaging stereotypes of Native Americans that cause real harm and is antithetical to the California school mission of providing an equal education to all; and

WHEREAS, the United States Commission on Civil Rights, among other organizations, has concluded that the use of Native American images and names in school sports is a barrier to equality and understanding, and all residents of the U.S. would benefit from the discontinuance of their use; and

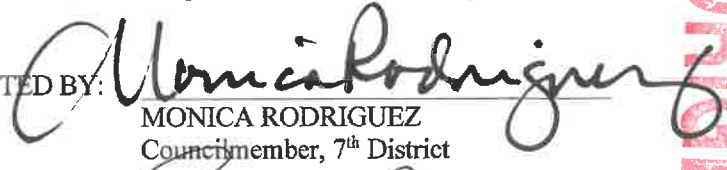
WHEREAS, currently pending before the State Assembly is Assembly Bill (AB) 3074 which would expand the 2015 California Racial Mascots Act to impose a State-mandated local program that prohibits public schools from using any derogatory Native American term as a school or athletic team name, mascot, or nickname, starting on July 1, 2026; and

WHEREAS, public schools operated by a Native American tribe or a tribal organization would be exempt from the prohibition; and

WHEREAS, AB 3074 would also require the Uniform Complaint Procedures, a system to process allegations of discrimination, harassment, intimidation, or bullying to apply to school or athletic team names, mascots, or nicknames; and

WHEREAS, AB 3074 would fulfill the original intent of the 2015 California Racial Mascots Act to prohibit the use of any racially derogatory or discriminatory school or athletic team names, mascots, or nicknames in California public schools;

NOW, THEREFORE, BE IT RESOLVED, that by adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-24 State Legislative Program SUPPORT for Assembly Bill 3074 to prohibit public schools from using any derogatory Native American term as a school or athletic team name, mascot, or nickname, and make school or athletic team names, mascots, and nicknames subject to the Uniform Complaint Procedures.

The City of Los Angeles is part of a worldwide movement to re-evaluate attitudes toward consumption, disposal, product stewardship, and infrastructure to reduce plastic waste and promote sustainability. Since 2013, the City, through the Bureau of Sanitation, has demonstrated its commitment to zero waste and the reduction of single-use plastics through various ordinances, most notably through the single-use carryout bag ban and the expanded EPS ban.


The City is now proposing to expand on these measures by implementing a city-wide Comprehensive Plastics Reduction Program. The City is evaluating numerous measures to reduce or eliminate the production and use of single-use plastic products, and encourage reuse or recycling of other items to the extent feasible, thereby reducing or eliminating the input of single-use plastics into the City’s waste stream and the environment.

These are known as upstream measures because they keep single-use plastics from entering the use and disposal streams. These upstream measures include bans on specific single-use products; product stewardship programs; extended producer responsibility (EPR) programs targeting specific items; policies to require and/or support the manufacturing of durable, reusable, repairable, and recyclable products; and the formation of working groups to evaluate program efficacy and conduct additional studies.

In a 2021 resolution, the City stated that the use of single-use printer cartridges is growing rapidly due to increased flow of aftermarket, new built, single-use printer cartridges that are imported from foreign manufacturers. In this resolution the City notes that single-use printer cartridges can take between 450 and 1,000 years to decompose in landfills.

A ban on single-use printer cartridges would potentially reduce the number of cartridges that end up in landfills due to replacement products which could be recycled for reuse. Therefore, a ban on single-use printer cartridges would result in a beneficial impact on the City’s solid waste stream, as well reduce public exposure to hazardous materials by keeping printer cartridges out of landfills.

I THEREFORE MOVE that the City Council request the City Attorney, in consultation with the Bureau of Sanitation, to prepare and present an ordinance prohibiting the distribution and sale of aftermarket single-use clone-compatible printer cartridges.

MOTION

For over a decade, the Los Angeles Police Department (Department) has collaborated with community partners to build invaluable youth programs and bridge programs that prepare young Angelenos for becoming members of law enforcement.

The Department's Cadet Program is a community-based crime prevention program that aims to empower youths, ages 13 to 17, and maximize their personal and scholastic potential through the emphasis of the program's four cornerstones: leadership, academic excellence, ethical and wise decision-making, and community stewardship. The Cadet Program is considered the Department's signature youth program and proven to be its most enduring.

A partnership between the Department and the Los Angeles Unified School District has created unique and innovative secondary law enforcement schools known as the Police Academy Magnet Schools (PAMS). The PAMS program offers an academically and physically rigorous career pathway for young men and women interested in law enforcement and criminal justice by providing a better understanding of law enforcement and a recruitment avenue of diverse and highly qualified candidates for the Department.

There is also the Associate Community Officer Program (ACOP) to assist young adults, ages 17 ½ to 20, who have proven to be outstanding participants in the Department's youth programs—such as the Cadet Program or a PAMS program—and have expressed the desire and commitment to join the Department as a sworn officer. ACOP offers short-term employment to bridge the gap for young adults until they are legally eligible to apply for the Department.

Then there is the Police Orientation Preparations Program (POPP), which is a two-year Associate degree program for high school graduates which is supported by both the Department and the Los Angeles Community College District. POPP is open to any graduate from a PAMS high school program, a cadet of the Cadet Program, or any other law enforcement agency cadet program. In the POPP program, students complete all academic requirements for an Associate of Science Degree in Administration of Justice, which is fully transferable to California State and University of California colleges.

These programs are crucial for recruiting the next generation of sworn law enforcement officers, in whom the public trusts with their everyday safety.

I THEREFORE MOVE that the City Council instruct the Police Department to report on the current status of the Cadet Program, the Policy Academy Magnet Schools (PAMS) Program, the Associated Community Officer Program (ACOP) and the Police Orientation Preparations Program (POPP), including program elements, participation and enrollment levels, and how these programs work collectively to provide viable pathways for youth to pursue law enforcement careers with the Department and thereby assist the Department in meeting its recruitment objectives.

I FURTHER MOVE that the City Council instruct the Police Department to also report on options to expand participation in these programs; and bridge any potential program gaps which may exist. The expansion of these programs may also include the development of public awareness/outreach campaigns and incentives in order to increase participation rates.
