Located in a High Fire Severity Zone, the 75-year-old community was most recently impacted by the 2019 Getty Fire when it had to mandatorily evacuate, avoiding further danger thanks to the hard work of first responders.

As climate change increases the prevalence and risk of wildfires, members of the Crestwood Hills Community have expressed concern regarding overhead utility lines that may put the hillside at heightened risk for these types of climate change induced events.

To address this concern, the community is organizing to develop a uniformed streetscape for this area and is looking toward the City to help them resolve these concerns. The Crestwood Hills focal area should consist of N. Kenter Avenue and Kenter Way on the west, Sky Lane to the north, North Tigertail Road to the east and Rochedale Lane, including Rochedale Way – Bramble Way – Broom Way to the south.

I THEREFORE MOVE that, under the authority granted by Ordinance 145,148, the Los Angeles Department of Water and Power be requested to prepare a report analyzing the feasibility of establishing an underground utility district and identifying the estimated costs to implement for the Crestwood Hills Community in Council District 11.

I FURTHER MOVE that the feasibility report includes the status of the overhead powerlines in place and recommendations on how moving the utilities underground will improve output, service, and continued maintenance in the future, and the report should outline the most appropriate geographic area to place the underground utility district.

The Los Angeles 2028 (LA28) Games will mark Los Angeles' third time hosting the Olympic Games. It previously hosted the 1984 and 1932 games, and it's the first time hosting the Paralympic Games.

It is a chance to showcase the natural environment and historic structures around Los Angeles. With over 460 square miles that include coastline, hillsides, and everything in between, there is no shortage of beautiful places throughout the City.

As part of the Games Agreement, in Section 11: Arts and Cultural, LA28 is to work in close coordination with the City to develop arts and cultural programming that seeks to operationalize equity and inclusion through outreach to local artists, cultural producers, and leverage the Games experience across the culturally diverse neighborhoods in conjunction with the LA28 Games cultural programs.

The Art and Cultural Plan must include ways by which the 2028 Games cultural program will be integrated with the delivery of the 2028 Games. This needs to include a way of a series of event offerings that allow for spectators, residents, fans, and athletes a seamless opportunity to experience a multitude of artistic disciplines utilizing art and cultural facilities to better connect the Games. This should include working with neighborhood and local art organizations.

The Art and Cultural Plan should prioritize tickets for City of Los Angeles residents and have a component to ensure people from underserved communities have access.

For the 1984 Games, Robert Fitzpatrick was tasked with creating the Olympic Arts Festival program that laid out over 400 performances by 75 companies from 18 countries, in addition to 20 smaller displays, mini-festivals, and major arts exhibitions. It would not have been possible without the 1984 Los Angeles Organizing Committee.

It is important that for the LA28 games we display the rich artistic talent we have in the City of Los Angeles. We need to activate all of our Historic Sites as well as local venues that can help the residents and visitors to our City experience the diverse culture of Los Angeles.

I THEREFORE MOVE that Council DIRECTS the Department of Cultural Affairs, with the assistance of the City Administrative Officer, the Chief Legislative Analyst, and REQUEST LA28 to report on the status of planning for the Olympic Arts Festival for the LA28 Games, including how the Festival will engage the broadest range of performing arts centers, museums, galleries, and other types of venues throughout the City of Los Angeles as possible.

#### **MOTION**

Los Angeles has taken the Olympic torch from Paris, and will serve as the host of the next Olympic and Paralympic Summer Games in 2028. The 2028 Games, independently operated by the Olympic Organizing Committee (LA28), are expected to bring tens of thousands of athletes, and millions of visitors, to the City to experience these world-class events, and with it great opportunity for the businesses and workforce of Los Angeles

As part of the Games Agreement, the City Council approved the creation of three working groups to aid in Olympic and Paralympic Games Planning, including the Local Hire Working Group (LHWG). The LHWG is tasked with developing and implementing a program to ensure that the 2028 Games workforce is fully representative of the diversity of Los Angeles, including programs for youth and transitional workers, and a volunteer program to maximize public benefit in connection with the 2028 Games

The LHWG is actively developing recommendations to ensure employment opportunities are available to the local workforce. The City should provide information to the LHWG relative to resources currently available to engage with the employment system in Los Angeles and ensure the LHWG's recommendations are robust and achievable for the 2028 Games.

I THEREFORE MOVE that the Council request the City Administrative Officer, the Chief Legislative Analyst, and the City Attorney to work with LA28 to establish and document employment opportunities available for the local workforce in the City of Los Angeles and provide a report to Council detailing how opportunities will be promoted to the City workers;

I FURTHER MOVE that the Council request the Bureau of Contract Administration and the Economic and Workforce Development Department, with the assistance of the City Administrative Officer, to provide LA28 recommendations on incorporating local hiring best practices in their employment strategy; and

I FURTHER MOVE that the Council request LA28 to provide estimates of local hiring by category and work with the Bureau of Contract Administration and the Economic Workforce Development Department to develop an outreach, education and training program leveraging current programs.

The Los Angeles 2028 (LA28) Games will mark Los Angeles' third time hosting the Olympic Games. It previously hosted the 1984 and 1932 games, and it's the first time hosting the Paralympic Games. The LA28 Games will be held July 14th - 30th, followed by the LA28 Paralympics from August 15th - 27th.

The LA28 Games will have over 50 Olympic and Paralympic sports in over 80 venues. However, the selected venues cover small areas across the City and have limited tickets for each event. It is important that the communities throughout all of Los Angeles are a part of the Olympics and Paralympics experience. Viewing parties and activations are important and fun ways to make sure these events reach every Angeleno.

As part of the Games agreement, the City Integration Plan (Section 6.5.1), LA28 shall include plans for live sites and activations to be held within the City in conjunction with the 2028 Games. The plan shall be completed by March 2026.

The City of Los Angeles is over 460 square miles with diverse neighborhoods and it is crucial that the 2028 Games are accessible to all Angelenos regardless of where they live. With the Games concentrated in spaces that historically host large scale events, some communities may not feel a direct connection, especially those in the San Fernando Valley and Harbor and that must be remedied by free viewing parties and activations across the City.

For all Angelenos to feel that they can participate in the celebration of the Olympics, LA28, in partnership with the City, should begin organizing view parties and other activations in communities throughout the City. These viewing parties and activations must be free of charge and should run for multiple days and have Olympic activities for residents to participate in.

I THEREFORE MOVE that Council DIRECT the Chief Legislative Analyst and the City Administrative Officer, in consultation with the Council Offices and all relevant Departments, and REQUEST LA28 to develop at least 28 locations throughout the City, in every Council District, including, but not limited to, non-City owned spaces, where viewing party locations and activations can be hosted to serve Angelenos.

The Los Angeles 2028 (LA28) Games will mark Los Angeles' third time hosting the Olympic Games. It previously hosted the 1984 and 1932 games, and it's the first time hosting the Paralympic Games. Los Angeles is expected to host 15,000 of the world's most elite athletes in 2028 as it welcomes Paralympians and Olympians from around the world to compete on the biggest stage in sports. The LA28 games are independently operated by a privately funded, non-profit organization.

There are many variables regarding how many visitors will attend the LA28 games. The 2024 Paris games are now concluding and the 2020 Tokyo games were severely impacted by COVID-19. Based on estimates of the 2016 Summer Olympics in Rio de Janeiro, Brazil, the games drew approximately 1.2 million tourists, 410,000 of whom were visitors from foreign countries.

Hosting large scale events has a great impact on not only the residents in Los Angeles but the business community as well. As part of the Games Agreement the City Council approved the creation of three working groups: Sustainability Working Group (SWG); Local Hire Working Group (LHWG); and Community Business and Procurement Working Group (CBPWG).

The CBPWG is critical to ensure that the small and medium businesses throughout the City have access to opportunities before and during the games. This working group should provide recommendations and a plan of action to support local businesses that are still recovering from COVID-19, post pandemic inflation and most importantly leverage the LA28 games for economic development and job creation in our City.

As the CBPWG is working on recommendations to engage local businesses on LA28 opportunities it is important for them to understand what resources are available for local businesses in the City of LA to ensure their recommendations can be implemented in an inclusive and equitable manner across the City.

I THEREFORE MOVE that Council DIRECT the City Administrative Officer, the Chief Legislative Analyst, and the City Attorney to work with LA28 on procurement opportunities available for small, medium, and large size businesses in the City of Los Angeles and provide a report to Council detailing how the opportunities will be promoted to local businesses;

I FURTHER MOVE that Council DIRECT the City Procurement Office, with the assistance of the City Administrative Officer, to provide LA28 recommendations on incorporating Local and Small sized businesses in their procurement strategy; and

I FURTHER MOVE that Council request LA28 to provide estimates of procurement spend by category and work with the Office of Procurement, the Bureau of Contract Administration, and the Economic Workforce Development Department to develop an outreach, education, and training program leveraging current programs.

Los Angeles is a city of renters where more than 60% of homes are occupied by renter households. Los Angeles is also a city where people tend to remain in neighborhoods for a long time – nearly 60% of the City's residents have lived in the same location for at least five years. The continuity of place provided by these long-term community members helps make Los Angeles a vibrant and welcoming place to live. Unfortunately, Los Angeles is currently in the throes of a catastrophic housing crisis with particularly harsh consequences for low-income households and communities of color that is leading to displacement of households and destabilizing communities.

In 2023, the City Council passed a comprehensive set of tenant protections in which it became a requirement for landlords/property managers to file the intent to evict a tenant with the Los Angeles Housing Department (LAHD). That same year, LAHD was mandated to create an eviction dashboard detailing information the City was receiving from eviction filings. Los Angeles Municipal Code (LAMC) §§ 151.09(C)(9) and 165.05(B)(5) require that written notice terminating a tenancy for a tenant at-fault legal reason must then be filed with LAHD within three business days. This serves as both a crucial method of data collection regarding City evictions and a useful tenant protection to ensure proper notices are filed in eviction proceedings.

Unfortunately, these filing requirements have not been fully effective in practice. There is currently a lack of enforcement when it comes to the timely filing of eviction notices by landlords, and LAHD has not always been able to verify if the reasons to evict indicated in the notices themselves are accurate and legal. Case managers and constituent services regularly report cases of tenants being evicted for less than one month's Fair Market Rent in spite of LAMC §§ 151.09(A)(1), as unrepresented tenants are rarely familiar with the regulations or the court system and are often unequipped to advocate for their rights. Additionally, landlords begin and prevail in eviction proceedings without filing this notice paperwork with LAHD. Even when landlords do file them, there is no streamlined process for tenants to access these notices, and many tenants are completely unaware they exist at all.

This problem is particularly serious in light of the short timeline of unlawful detainer cases, most of which require an answer from the tenant within five court days to avoid losing by default judgment. Under the current system, it is virtually impossible to take advantage of this notice requirement in any eviction case. This both abridges the due process of tenants and enables evictions even when they have not followed proper legal procedures.

I THEREFORE MOVE that the City Council instruct LAHD and request the Office of the City Attorney to report back within 60 days with recommendations to ensure LAMC 151.09(C)(9) and 165.05(B)(5) can better protect tenants from evictions, especially in cases where landlords



have filed eviction cases that are not legal. The report should consult stakeholder organizations, including tenant advocacy groups and landlords, and consider findings produced in various reports compiled by such organizations. Specifically, the report should include:

- Number of notices that have been filed with LAHD citywide and by council district since the enactment of the ordinance, including the delivery method for each notice, relative to the number of evictions that have been filed with the courts within the City of Los Angeles within the same time period;
- Current processes and timeline for how the City verifies the legitimacy of filed notices and recommendations for how this can be more effectively and efficiently verified;
- Current processes for how tenants access filed notices, including how tenants may access these notices within the timeline of a typical unlawful detainer case;
- Current processes for informing landlords of this requirement;
- Current processes for enforcement against landlords who act out of compliance of this ordinance, including data on any enforcement actions that have been taken against landlords for violations to date;
- Current processes for partnership with elected offices, including but not limited to providing notices and tenant information in order to provide resources;
- Recommendations for educational outreach programming to encourage greater awareness and compliance for both tenants and landlords;
- Recommendations for potential amendments to align the noticing timeline in a more compatible fashion with the timeline for response to Unlawful Detainers while formally and informally collaborating with the courts to promote awareness and compliance of the municipal noticing requirement during the filing and serving processes for Unlawful Detainers; and

Recommendations for a potential enforcement structure for the notice requirements.

On August 14, 2024, the Council approved a motion instructing the Personnel Department and the Los Angeles Police Department (LAPD) to report with a framework and analysis for the transition of sworn and civilian hiring from the Personnel Department to LAPD (C.F. 24-0890). Several different City departments are involved in various code enforcement processes for properties across the City. In some instances, a city inspector will issue a Notice and Order to Comply (NTC) for violations of land use regulations and/or when general maintenance and repair types of violations are observed during an inspection. NTCs are issued based on the Los Angeles Municipal Code. Upon inspection, if it is found that a property violates applicable codes or standards, the inspector will issue an order that will list all violations.

A property owner has complied with the order when an inspector has verified the abatement of the cited violations in conformity with code requirements. Generally, notices provide 30 days to comply with the NTC. In some cases, an inspector may grant an extension of time. However, if the violation has not been corrected by the compliance period specified on the order or any extension thereafter, the case may be forwarded for enforcement.

What is unclear under current City practices is whether, during that 30-day period, a violation of land use must be terminated immediately, or whether the 30-day period can be used by the owner or operator to continue the use in question.

I THEREFORE MOVE that the City Council request the Los Angeles Housing Department and Department of Building and Safety, in coordination with the Office of the City Attorney, to report in less than 30 days on the ability of a property owner that has been issued a Notice and Order to Comply to continue to operate the use in question during the 30-day time window of the notice.
