BUDGET, FINANCE AND INNOVATION COMMITTEE REPORT relative to transferring \$3,000,000 from the Unappropriated Balance Fund, Mutual Aid Account and \$4,000,000 from the Constant Staffing Overtime Account, for a total of \$7,000,000, to the Los Angeles Fire Department's Sworn Overtime Account to cover projected funding needs.

Recommendations for Council action, pursuant to Motion (Lee - Blumenfield), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the Controller to transfer a total of \$3,000,000 from the Unappropriated Balance, Fund No. 100/58, Mutual Aid Account No. 580274, and \$4,000,000 from the Constant Staffing Overtime Account No. 001093, for a total of \$7,000,000, to the Sworn Overtime Account No. 001092 to cover projected funding needs in this account.

2. AUTHORIZE and INSTRUCT the City Administrative Officer (CAO) and Controller to take any necessary actions and make any technical corrections to the above instructions in order to effectuate the intent of this Motion.
