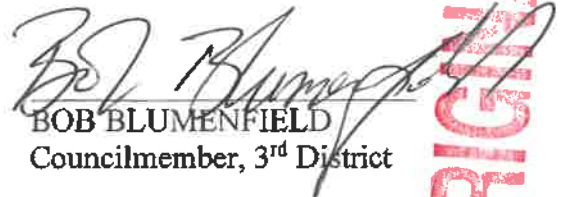

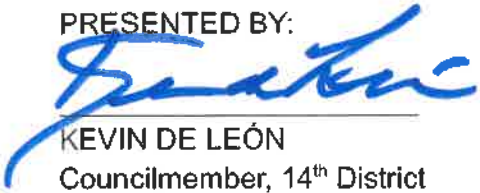

Mr. Buchanan was transported to Harbor/UCLA Hospital by the Los Angeles City Fire Department and was pronounced deceased later that day.

The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles; therefore, it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of the person or persons responsible for the death of Clay Buchanan.


I THEREFORE MOVE that by adoption of this Motion, the City Council provide an offer of reward for information leading to the identification, apprehension, and conviction of the person or persons responsible for the death of Clay Buchanan on August 6, 2023, and in support thereof, make the following findings pursuant to Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code:

1. That the death of Clay Buchanan was caused by the willful misconduct of one or more persons.
2. That this offer of reward is consistent with and taken for the immediate protection of the public peace, health and safety of local residents, as well as visitors to the City, and is consistent with the need to arrest and convict the person or persons who, because of not being apprehended, could by their actions further terrorize and present a continuing and immediate menace to the rights of persons in the City.

That what happened to the victim is an especially disturbing crime and therefore, as a matter of public policy, the City hereby offers a reward as an added inducement for persons to come forward with information leading to the identification, apprehension and conviction of the person or persons responsible for the death of Clay Buchanan.
4. That the sum of \$50,000 shall be the aggregate maximum sum of any payment or payments of a City reward in this instance.
5. That the offer of reward shall be in effect for six months from the date of the advertisement of the reward by the City Clerk.

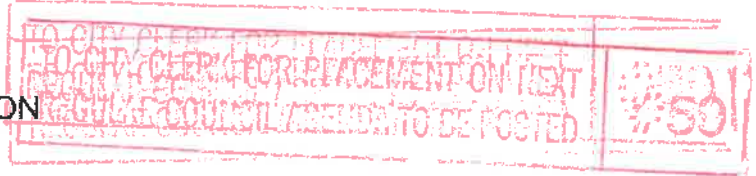

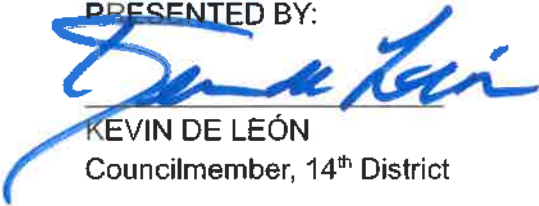

The Port of Los Angeles is a major gateway for international commerce and the busiest port in the Western Hemisphere. The Port encompasses 7,500 acres of land and water along 43 miles of waterfront. In addition to handling both passenger and cargo terminals, the surrounding warehouse facilities manage billions worth of cargo each year. Currently, the Port is undertaking a multi-year \$2.6 billion infrastructure investment program to increase cargo efficiency and improve the supply chain. In addition, the Port must balance environmental initiatives, security measures, and the revitalization of public-friendly amenities and infrastructure to ensure that the harbor shoreline is a world-class visitor destination.

On November 5, 2024, City voters were presented with six Charter measures that comprise the most comprehensive set of governmental reforms since the 1999 Charter Reform effort. Among these measures, the City advanced multiple changes to improve departmental efficiency and transparency, including a requirement that two members of the Board of Harbor Commissioners reside within the Harbor area, one from the community of San Pedro and one from the community of Wilmington, which will help ensure that ample local participation occur as the Port continues to invest in the area.

Voters overwhelmingly supported the Charter reforms, approving each measure by well over a supermajority of votes cast. Currently, Charter Section 650 requires one member of the commission reside in the "Harbor Area," which is defined by ordinance and codified in Los Angeles Administrative Code (LAAC) Section 23.49. The Council will now need to amend the LAAC to comply with the new Charter provision.

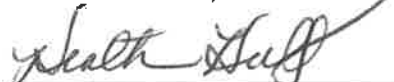

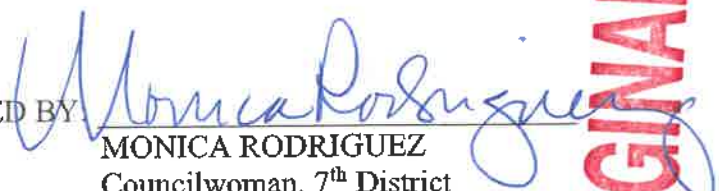

WHEREAS, Section 80.69 of the Los Angeles Municipal Code authorizes the Department of Transportation (LADOT) to prohibit the parking of vehicles when the unrestricted parking of vehicles would create a hazard or detrimentally affect public welfare; and

WHEREAS, the Los Angeles Fire Department (LAFD) has designated several street segments within Council District 7 to be within a Very High Fire Hazard Severity Zone and has identified hazardous activities along these street segments that are directly associated with parked and stopped vehicles such as: open fires, illegal dumping, tampering with utilities, and occupying private properties within the fire zone; and

WHEREAS, the LAFD has determined that "No Stopping at Any Time" parking restriction signs should be installed along these street segments, as well as installing red curbs adjacent to fire hydrants in distances consistent with the Los Angeles Municipal Code and the California Vehicle Code;

NOW, THEREFORE BE IT RESOLVED that the Council, pursuant to California Vehicle Code Section 22507(a) and Los Angeles Municipal Code Section 80.69, hereby instructs the Department of Transportation (LADOT) to post "No Stopping Any Time" signage and red curbs next to fire hydrants in distances consistent with the Los Angeles Municipal Code and the California Vehicle Code along the following street segments to address fire hazards associated with their locations in a Very High Fire Hazard Severity Zone and the potential to detrimentally affect public welfare:

- Both sides of 16211-16350 Filbert Street
- North side of Foothill Boulevard between Cambria Way and 500 feet west of Glenoaks Boulevard
- South side of Foothill Boulevard between Ararat Street and Cobalt Street
- Both sides of 16601 Foothill Boulevard (210 Freeway) to Balboa Boulevard

BE IT FURTHER RESOLVED, that the LADOT be authorized to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

ECONOMIC DEVELOPMENT & JOBS

In February 2021, the City Council adopted a motion (CF 13-0197-S13) to create a Transportation Technology Innovation Zone in the Warner Center in the West San Fernando Valley and to encourage and incentivize the development of innovative transportation technologies in this area. Although this action has not resulted in substantive changes to City policies, it has attracted a combination of private investment and State grant funding.

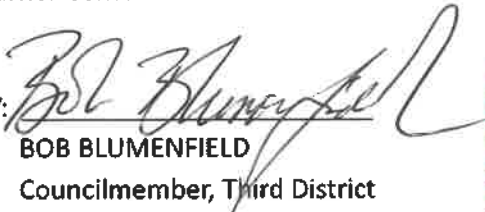
The 2-square-mile Warner Center has experienced substantial growth in recent years and that growth is expected to continue, due in large part to the Warner Center 2035 Specific Plan, with more than 11,000 housing units and 3.5 million square feet of commercial development constructed, approved or proposed since 2008. The City should continue its efforts to promote economic vitality in this area.

The City and other Warner Center entities originally partnered with Urban Movement Labs (UML) to assist in development of policies and administration of grants in the Transportation Technology Innovation Zone. UML has since been absorbed by the LA Cleantech Incubator, which has a broader focus beyond transportation to include other technological advances and the broader green economy.

In addition, Warner Center has seen recent growth in the biohealth, biomedical and biotech sectors. Expanding the scope of the TTIZ will support initiatives in this growing business sector, helping to create more jobs in Warner Center.

The enhanced scope of the TTIZ presents an opportunity for the City to expand Warner Center's goals to include transportation and technological innovation, including biohealth, biomedical and biotech.

I THEREFORE MOVE that the City of Los Angeles establish the Transportation and Technology Innovation Zone in the Warner Center.

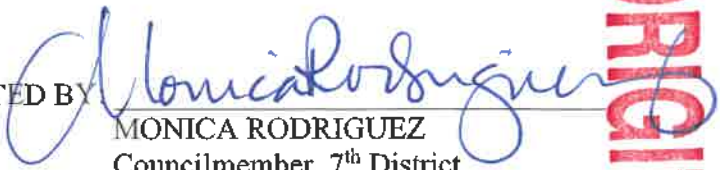
Pursuant to State Vehicle Code Section 21101.4, the City is authorized to undertake the temporary closure of public streets, alleys, and walkways to mitigate criminal activity. When necessary for the continued mitigation of criminal activity, temporary closures authorized under Section 21101.4 may be extended for “eight additional consecutive periods of not more than 18 months each.”

On August 18, 2020, the City Council approved the extension of the temporary closure of three walkways in the Mission Hills neighborhood northeast of Sharp Avenue and southwest of the Interstate 5 Highway between San Fernando Mission Boulevard and MacNeil Street for a period of 18 months (C.F. 12-0398-S2). The extension of the closure was requested by residents and was supported by the Police Department to address multiple public safety concerns at the time including graffiti, loitering, and illegal drug use occurring on the three walkways.

Since then, the approval of the temporary closure has expired. However, nearby residents support the continuation of this street closure to prevent crime in this area and have reported incidents of arson, illegal dumping, and graffiti occurring along these walkways. Additionally, residents will accept responsibility for the installation of any needed fencing.

I THEREFORE MOVE that the City Engineer be instructed to report with recommendations to temporarily close the three walkways northeast of Sharp Avenue and southwest of the Interstate 5 Highway between San Fernando Mission Boulevard and MacNeil Street for a period of eighteen months, pursuant to State Vehicle Code Section 21101.4.

Currently the City has three primary permits for applicants organizing special events: the Bureau of Street Services' Special Event Permit, the Police Department's Special Event Permit for parades and assemblies, and the Department of Building and Safety's Temporary Special Event Permit.

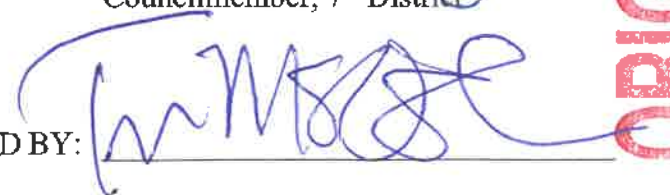
The Bureau of Street Services administers the City's Special Events Permit, which covers the majority of special events that occur on City property or within the public right-of-way, including community, athletic, charitable, commercial, and City-sponsored events and farmer's markets. However, the Police Department is responsible for permitting Parades and Assemblies that also occur within the public right-of-way, but follow separate procedures from the Bureau of Street Services. The Department of Transportation assists both the Bureau of Street Services and the Police Department in addressing potential traffic impacts of event applications.

The third type of special event permit, the Temporary Special Event Permit, which is administered by the Department of Building and Safety, regulates the use of temporary structures, including large tents, bleachers, stages, and grandstands, that are used for special events, including events held on private property. The Department of City Planning, Fire Department, and Police Department may also assist the Department of Building and Safety in reviewing a Temporary Special Event Permit.

Each of these three special event permits is managed and administered by rules and application processes entirely separate from each other with little to no conformity. The City should take steps to centralize the application process for these permits as it may often be unclear to applicants which permit is needed for their events and the current decentralized processes create confusion for potential applicants.

I THEREFORE MOVE that the Bureau of Street Services, Police Department, and Department of Building and Safety, with the assistance of the Information Technology Agency and Department of Transportation, be instructed to report with an overview of the various City special event permits and application procedures and recommendations to create a single online portal for applicants.

The Sepulveda Basin, a vital recreational, environmental, and flood control resource in the San Fernando Valley, has been the focus of multiple significant projects involving various City departments and government agencies. These include the Department of Recreation and Parks' (RAP) ongoing capital planning and programming, the Bureau of Engineering's (BOE) Vision Plan and river de-channelization work and numerous capital projects, LA Sanitation and Environment's (LASAN) oversight and upgrades to the Donald C. Tillman (DCT) Water Reclamation Plant, LA County Flood Control District's projects for the L.A. River, and the U.S. Army Corps of Engineers' (USACE) Sepulveda Dam Master Plan for flood control and environmental sustainability.

However, there have been persistent communication challenges between the public, City departments, federal agencies, and community stakeholders regarding what is happening in this space. This challenge is all more apparent as the Basin will host three events during the LA28 Games, as attendees for Basin LA28 events have no central source of updates. It is essential that the public has access to accurate, timely, and clear information. Furthermore, active community groups like the Lake Balboa, Van Nuys, and Encino Neighborhood Councils, Friends of the LA River, the Audubon Society, and the Basin Wildlife Steering Committee play important roles in the Basin's development and should be fully integrated into communication efforts. A dedicated website, modeled after Griffith Park's website would serve as a centralized hub to address these communication gaps, ensuring the public, City departments, and federal agencies can access and share critical information. This will enhance transparency, community engagement, and efficient coordination among all parties involved in transforming the basin for LA28 and beyond.

I THEREFORE MOVE that the City Council request the Department of Recreation and Parks with the assistance of the Information Technology Agency, the Bureau of Engineering, LA Sanitation and Environment, and the City Administrative Officer to report within 60 days with a work plan to develop a website for the Sepulveda Basin, a plan for coordination with the U.S. Army Corps of Engineers, a timeline for completion, staffing needs, and the anticipated budget for the development and maintenance of the website, including using in-house staff versus external contractors, as well as potential sponsorships tied to the 2028 Olympics, grants, and collaborations with local organizations.

I FURTHER MOVE that the website include:

- a) Existing recreational facilities, events, and programming within the park, including community activities, festivals, sports leagues, and Olympic-related events.
- b) Construction and infrastructure projects updates including updates from the BOE on the Vision Plan and river widening efforts, LASAN on the DCT Plant, Metro's G line improvements, USACE on the Master Plan's implementation, and other projects in planning from RAP or other departments.
- c) Transportation and navigation within the park, including a virtual map, information on parking lots, major paths, and Metro and DASH bus access.
- d) Emergency alerts related to safety concerns, natural disasters, or traffic impacts, especially as the area prepares for the Olympics.

- e) Volunteer and community opportunities to engage in basin cleanups, tree planting, and other efforts related to Olympic preparations.
- f) Ongoing sustainability initiatives, including environmental restoration projects and flood control improvements, in coordination with the USACE and other relevant agencies.
- g) Links to active community groups such as the Lake Balboa, Van Nuys, and Encino Neighborhood Councils, the Audubon Society, and the Basin Wildlife Steering Committee, to ensure local stakeholders are integrated into communication efforts and the public can engage with these groups.
- h) Environmental and sustainability efforts, highlighting improvements tied to the Vision Plan and the USACE's Master Plan, ensuring that the basin remains a key flood control and environmental asset.
- i) Multilingual features on the website to make information accessible to diverse communities and international visitors expected during the 2028 Olympics.
- j) Community input to ensure the website meets the needs of local park users and international visitors, with a special focus on accessibility during Olympic preparations, public safety, and implementation of the Vision Plan and the USACE's Master Plan.

I FURTHER MOVE that the Department of Recreation and Parks, the Bureau of Engineering, and LA Sanitation and Environment coordinate with the Los Angeles Organizing Committee for the 2028 Olympics to ensure the website provides comprehensive and timely information on Olympic preparations, park improvements, and Master Plan milestones.

Existing law allows cities and counties to license any legal business conducted within its jurisdiction, and enact license fees and taxes, some of which are measured by a business's gross receipts for purposes of these taxes. Over several years, state legislation has been approved, including Proposition 64, that has complicated the definition of how cannabis taxation should be applied by local jurisdictions. As a result, local jurisdictions that use the definition of gross receipts incorporate the cannabis excise tax as part of their base calculation for local cannabis business taxes and fees. This results in a compounding tax, where the amount from the imposition of one tax is included in the base calculation for a subsequent tax levied by a local jurisdiction, resulting in a double taxation system. This counters sound tax policy as it results in the application of tax on a tax, rather than a tax on the actual goods that are being sold.

Senate Bill (SB) 1059 (Bradford), which was recently signed by the Governor on September 28, 2024, would prohibit local jurisdictions from including in their definition of gross receipts any taxes that are applied under the Cannabis Tax Law, the Sale and Use Tax Law, and the Transaction and Use Tax law, for the purposes of local cannabis business taxes and fees. This would result in an adjustment that would reduce the base calculation upon which local jurisdictions may levy a tax or fee when licensing cannabis businesses.

SB 1059 will assist the legal cannabis industry by alleviating some of the tax burdens that are placed on licensed cannabis retailers. The current calculation method being used is unfair to consumers, and places licensed retailers at a disadvantage as they continue to struggle against a thriving illegal cannabis market. Consumers are driven towards the unlicensed and untested cannabis market as the current calculation method inflates the price of licensed cannabis products. SB 1059 corrects previous legislation to improve taxation of cannabis and cannabis products..

I THEREFORE MOVE that the City Council instruct the Office of Finance and the Department of Cannabis Regulation, with the assistance of the City Attorney, to report with recommendations to align the City's definition of gross receipts tax with the provisions of Senate Bill 1059 (Bradford), as well as to report on the potential impact on the City's revenues relative to the collection of business taxes for cannabis and cannabis-related products.

Streetlights are a core piece of the City's local infrastructure that improves both public safety and quality of life for residents. However, the Bureau of Street Lighting, the agency tasked with maintaining and repairing the streetlight system, does not have a systematic means of monitoring its streetlights.

The primary means that the Bureau has to identify lights in need of repair are via residents either notifying the City through spaces like 311 or by Council Offices contacting them. This results in outages being addressed in areas where residents are quickest and most vigilant to report issues to the City and outages persisting in communities where residents are either unaware of how to report outages or reluctant to engage with the government to actively request repairs.

The City should explore options to actively monitor the status of streetlights throughout the City in order to become less reliant on residents' reporting of outages to address issues, whether this be through the use of staff to survey the status of streetlights or the implementation of new technology and equipment that can allow for real-time monitoring of a streetlight's status, similar to the system LADOT has in place for its traffic signals. Additionally, the City should review where outages are and are not being reported by residents so that resources may be deployed to more equitably address streetlight outages around the City.

I THEREFORE MOVE that the Bureau of Street Lighting and the Information Technology Agency be instructed to report with an overview of where street lighting outages and streetlight related MyLA311 requests are concentrated around the City.

I FURTHER MOVE that the Bureau of Street Lighting be instructed to report with recommendations to actively monitor the status of the City's streetlights, including the feasibility of utilizing new technologies, such as but not limited to AI, to allow for real-time monitoring of the condition of City streetlights.

Known for its extensive menu of both Japanese and Chinese staples like handmade gyoza, ramen, and mapo tofu, Kouraku remains a popular late-night spot embodying the simplicity and depth of home-cooked meals that reflect a rich Japanese history.

After Mr. Yamauchi's passing in 2020, then manager Mamoru Tokuda took ownership. His continued commitment to uphold established traditions, while embracing new flavors, celebrates Little Tokyo's enduring diversity. Kouraku remains a family-run establishment dedicated to serving labor-intensive, traditional cuisine that is reminiscent of a home never forgotten.

As Kouraku nears its 50th anniversary, it remains a steadfast presence in Little Tokyo. Serving as the social, cultural, and economic heart of Japanese Americans in Los Angeles. Kouraku's resilience and dedication to heritage echo the broader story of Little Tokyo itself.

I THEREFORE MOVE, in recognition of the cultural and historical significance of Kouraku Restaurant, to authorize the Department of Transportation to fabricate an Historical Monument sign stating: "KOURAKU: AMERICA'S OLDEST RAMEN SHOP STILL IN OPERATION 314 E 2ND ST., LA ESTABLISHED IN 1976", and instruct the Department of Transportation to install the double-sided sign on the streetlight pole located at 314 E 2nd Street in Downtown Los Angeles.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, State, or federal governmental body or agency must first have been adopted in the form of a Resolution by the City Council; and

WHEREAS, film and television production is an essential facet of the the cultural, economic, and historical fabric of Los Angeles, providing significant benefits and tens of thousands of jobs that support the residents of the City; and

WHEREAS, the State Legislature passed AB x3 15 (Krekorian) to create the first Film & Television Tax Credit Program in 2009 as a response to increased incentives and pressure from foreign countries and U.S. states competing for film and television production, with \$100 million dollars available for incentives annually; and

WHEREAS, the Film & Television Tax Credit Program has been expanded and modified since 2009, and it has generated over \$26 billion in economic activity and directly supported over 197,000 jobs across the State; and

WHEREAS, the current Film & Television Tax Credit Program, which will run through 2030, is capped at \$330 million dollars annually, and is regularly oversubscribed, leading productions to film in competing states, which then benefit from the generated economic activity that could instead have taken place in California; and

WHEREAS, on October 27, 2024, Governor Gavin Newsom announced a proposal to expand the Film & Television Tax Credit Program to offer \$750 million in incentives annually, more than doubling the present incentive cap, and positioning California as the state with the highest incentive cap in the nation; and

WHEREAS, expanding the Film & Television Tax Credit Program would keep vital film and television productions in California, providing jobs and generating economic activity that will benefit Los Angeles residents;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2025-2026 State Legislative Program SUPPORT for an expansion of the Film & Television Tax Credit Program's annual incentive cap to \$750 million.

HOUSING & HOMELESSNESS

1537-1541 W. Cambria St was an apartment complex that embodied L.A.'s robust cultural heritage. The complex housed 45 tenants, 12 of whom were children, and all tenants shared a common indigenous language, with Spanish as a second language for many. Many of the families had lived there for over 20 years. The residents were classified as extremely-low-income, paying only \$1,700 per month for three and four bedroom units.

877 N. Bunker Hill Ave encompassed 20 units filled with long-time tenants, of whom the overwhelming majority were low-income, monolingual Chinese language speaking, seniors. Making their homes in Chinatown was not simply a matter of preference, but a matter of necessity as it is the only neighborhood in the City that was truly language-accessible to them.

Within the last year, both of these buildings caught fire, rendering them entirely uninhabitable and leaving the residents without a place to live. In the case of 1537-1541 W. Cambria, the building was soon demolished and most tenants received almost no compensation. For the tenants of 877 N. Bunker Hill, since September 13, 2024 they have been living in motels during the long search for suitable long term housing, with affordability and proximity to Chinatown being some of the key challenges. In the immediate aftermath of the fire, these vulnerable seniors - some with serious medical conditions - were sleeping in cots at Alpine Recreation Center. Unfortunately, these are not uncommon stories.

While Los Angeles does not keep comprehensive records of how many tenants are displaced due to disaster or how many are eligible for a right to return, there are countless examples of individuals facing massive disruptions to their daily lives because of fires and other Acts of God and communities of color bear the brunt of these risks. Across Los Angeles County, the communities that are most at risk of catastrophic fire, flood, or other natural disasters tend to be lower income and less white than the county as a whole. Black residents in Los Angeles County are at higher risk for receiving catastrophic levels of floodwater, and they are 79% more likely than white residents to live in areas at risk of at least three feet of flooding.

I THEREFORE MOVE that the City Council INSTRUCT the Los Angeles Housing Department (LAHD) and REQUEST the City Attorney, to report within 30 days on potential amendments, additions and changes to the Los Angeles Municipal Code (LAMC), as well as exploring a new ordinance to establish the following protections for all residential tenants who are displaced temporarily or have their tenancy unilaterally terminated due to earthquake, fire, flood, natural disaster, civil disturbance, or other Acts of God. The report should consult stakeholder organizations, including tenant advocacy groups and landlords. Specifically, the report should include an analysis and recommendations, including specific model amendments to the current LAMC and/or a draft ordinance, that assess the following guidelines:

- Requiring property owners who seek to renovate, rebuild, or restore a unit after an earthquake, fire, flood, natural disaster, civil disturbance, or other Acts of God to comply with a Tenant Habitability Plan and to observe full compliance with all requirements set forth in the Tenant Habitability Plan Ordinance;
- Providing a displaced tenant whose contract has been terminated for the above-mentioned reasons the right of first return to their original unit, once repaired, if the Rent Stabilization Ordinance (RSO) or Just Cause Ordinance applies;
- Requiring property owners to provide relocation assistance to tenants who are permanently displaced pursuant to the tenant protection scheme in place prior to the displacement, and if none exists, then provide it at a rate recommended by LAHD and the City Attorney, in alignment with other City laws;

- Subjecting property owners who do not comply with the above rules to an enforcement scheme overseen by LAHD and the City Attorney that includes fines, fees, and a private right of action for tenants with a mandatory attorneys' fees clause for prevailing parties.

I FURTHER MOVE that the City Council **INSTRUCT** LAHD to report in 30 days on the following:

- Existing remedies in the LAMC that support relocation assistance for tenants who have been affected by an Act of God;
- Where in the LAMC there is coverage to ensure that tenant habitability is up to code, and how a tenant can file for recourse should a landlord be unresponsive to necessary building updates;
- In the event that a landlord or property owner's negligence is not found to be the cause of damage during an Act of God, what mechanisms exist for tenants to provide counter evidence.

I MOVE, regarding the matter of the COMMUNICATION FROM THE CITY ATTORNEY and ORDINANCE FIRST CONSIDERATION relative to adding Chapter 19 to Division 19 of the Los Angeles Administrative Code (LAAC) to prohibit City resources, including property and personnel, from being utilized for immigration enforcement or for cooperation with federal immigration agents, Item 52 on today's Council Agenda (C.F. 23-0243), that the City Attorney be requested to AMEND the draft ordinance as follows:

- 1) Add "Immigration Enforcement" as a defined term to match the definition in California Government Code Section 7284.4(f); and use this defined term as the basis for the limitations on the use of City resources imposed throughout Sec. 19.191;
- 2) Require all City employees to treat City data and information that can be used to distinguish or trace a person's Citizenship or Immigration Status, either on its own or when combined with other information, as confidential information to the extent permitted by law, and require employees to handle, maintain, and secure such information according to City policy;
- 3) Clarify that nothing in the ordinance is intended to prohibit or otherwise restrict the City from complying with a valid warrant issued by a federal or state judge, or other order evidencing a judicial determination of probable cause;
- 4) Amend Sec. 19.191, Subsection (b), to read as follows: (b). Investigate, cite, arrest, hold, transfer, or detain any person for the purpose of Immigration Enforcement;
- 5) Amend Sec. 19.191, Subsection (e), to delete the phrase "absent informed, written consent from the person in custody."

I FURTHER MOVE that Item 52 on today's City Council agenda (C.F. 23-0243), be amended as follows:

That the City Council direct the Chief Legislative Analyst (CLA), with the assistance of any other City departments, as needed, to report back within 60 days with recommendations for reviewing compliance with this ordinance on an ongoing basis, including:

- A means of ensuring that all City departments, including the proprietary departments (the Department of Airports, the Harbor Department, and the Los Angeles Department of Water and Power), and the Los Angeles Police Department, can be compelled to adopt this same ordinance or a similar ordinance containing all the same provisions;
- A means of ensuring that all City departments, including the proprietary departments and the Los Angeles Police Department, are held to one uniform set of compliance standards such as educating and training staff about the ordinance, identifying violations, and addressing incidents of violations of the ordinance. These recommendations should include any resources and/or staffing needed to effectuate these responsibilities.

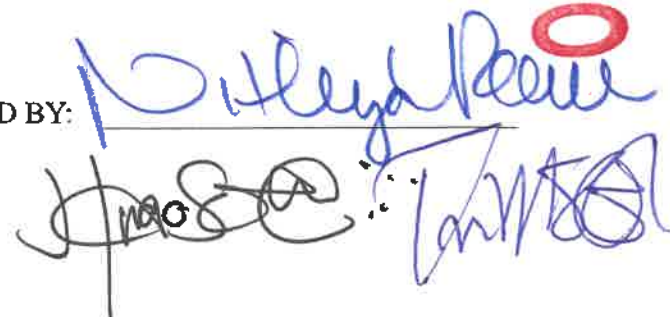
