Recommendations for Council action:

- 1. NOTE and FILE the Los Angeles Homeless Services Authority (LAHSA) report dated September 26, 2024 attached to the Council file.
- 2. \*APPROVE the proposed interim housing bed rates, as applicable, to be effectuated January 1, 2025, at the Level Staffing Model, Wage Tier 1 rates as follows:
  - a. \$69 per bed per night for sites with 51 beds or more.

- b. \$79 per bed per night for sites with 50 beds or less.
- 3. APPROVE a 12 percent administrative rate for Service Providers beginning January 1, 2025, which is included in the proposed interim housing bed rates within the City Administrative Officer (CAO) report dated October 2, 2024, attached to the Council file.
- 4. INSTRUCT the CAO to identify funding and include the necessary authorities to execute new or amend existing contracts to effectuate the increased bed rates in a future report.
- 5. APPROVE the proposed interim housing bed rates, as applicable, to be effectuated July 1, 2025, at the Enhanced Staffing Model, Wage Tier 1 rates as follows:
  - a. \$89 per bed per night for sites with 51 beds or more.
  - b. \$116 per bed per night for sites with 50 beds or less.
- 6. DIRECT the CAO, Chief Legislative Analyst (CLA), and REQUEST the LAHSA to report to Council on additional funding opportunities to cover gaps in operating costs for interim housing sites.
- 7. DIRECT the CAO and CLA to consult with Council Offices to identify expanded services and associated costs to provide those services in interim housing sites.
- 8. INSTRUCT the CAO to solicit the County of Los Angeles for payment for client services equivalent to the payments and services provided at Inside Safe sites and Mayfair Hotel. All City-funded single adult beds must follow the bed rate approved in the CAO report. For any bed that is currently negotiated at a higher rate, including Inside Safe beds, upon renegotiation they must follow the CAO's recommended Bed Rate listed in the report.
- 9. INSTRUCT the Los Angeles Housing Department (LAHD) to amend any contract regarding the operations of interim housing facilities with the LAHSA to include a requirement that the Scope of Required

The Harbor Department will be financially responsible for up to \$1,982,550.11 in costs including an amount not to exceed \$250,000 per calendar year or

\$1,250,000 over a five-year period, plus a one-time payment of \$732,550.11 to cover past eligible reimbursement expenses. Fiscal Year 2025 funding in the aggregate amount of \$982,550.11 is available within the Unallocated Capital Improvement Program Fund, Center 900, subject to approval by the Project Development Committee. Any unused balance at the end of each calendar year will not be carried over to the following year. Future year funding will be requested through the annual budget adoption process, subject to BOHC approval. Compensation under provisions of the Lease remains unchanged with a fixed three percent of gross receipts being collected from any operations occurring during construction. The recommendations in the report and proposed actions comply with the Harbor Department's Financial Policies. There is no impact on the City's General Fund.

In 2007, Council adopted a motion accepting the Century City Neighborhood Traffic Management Plan (CCNTMP), prepared by the Los Angeles Department of Transportation (LADOT) in consultation with Council District 5, and various community and homeowner organizations.

The plan aimed to address prospective traffic and pedestrian safety issues brought about by added congestion and development in the neighborhood. As a result, the Century City Neighborhood Traffic Protection Trust Fund No. 47M was created to accept funding generated by local development to fund pedestrian and traffic safety improvements in the immediate neighborhood.

In 2024, at the request of community members concerned about traffic safety, and an increase in street takeovers citywide, leaders from the Cheviot Hills community petitioned the Council Office to explore the implementation of ALPRs (Automated License Plate Readers) in the neighborhood.

I THEREFORE MOVE that \$114,000 be transferred/appropriated from the Century City Neighborhood Traffic Protection Trust Fund, Fund 47M, Department 50, Account 50V031 titled Constellation Place Neighborhood to the Los Angeles Police Department, Fund 100, Department 70, Account 006010 Office and Administrative for the purchase and installation of automated license plate readers in the Cheviot Hills neighborhood.

#### **MOTION**

In 2019, the City enacted the Los Angeles Civil and Human Rights Ordinance to protect its residents and visitors against discrimination in the private sector areas of commerce, education, employment, and housing. Subsequently, the City also passed an ordinance to establish the Civil and Human Rights and Equity Department (CHRED) to investigate discrimination claims and enforce the Civil and Human Rights Ordinance across the City.

In March 2024, the City and CHRED announced its inaugural Notice of Violation under the Civil Rights law against Smart & Final Stores, LLC and Non-Stop Security Services for discriminatory conduct with one of its shoppers. Smart & Final Stores, LLC was issued a \$10,000 penalty and Non-Stop Security Services received a \$5,000 fine. Smart & Final Stores, LLC paid the penalty, while Non-Stop Security Services agreed to a settlement involving a reduced fine and commitment to retrain their staff to prevent similar incidents in the future.

One-time Council action was required for CHRED to accept the payment from Smart & Final Stores, LLC, as well as to pay the claimant in the matter. CHRED is seeking to establish a process by which to accept penalties and fees and make payments to claimants by creating a Civil Rights Trust Fund for its civil rights enforcement efforts. The City has established various trust funds to carry out special functions and projects, including the Department of Cultural Affairs' Arts Development Fund, the Department of Transportation's Mobile Source Air Pollution Reduction Trust Fund, and the Department of Public Works' Environmental Affairs Trust Fund.

Creation of the Civil Rights Trust Fund would allow the Department to collect administrative and compensatory penalties for civil rights violations, as well as make payments to claimants in accordance with Los Angeles Municipal Code Section 51.07. Any administrative penalties received would assist the Department with enforcing the City's civil rights laws, including, but not limited to, technical services and training for investigators, case management systems for investigations and litigation, court reporters, and process servers.

I THEREFORE MOVE that the Council instruct the City Administrative Officer (CAO) and the Civil and Human Rights and Equity Department (CHRED), with the assistance of the City Attorney, to report in 30 days on the establishment of a Civil Rights Trust Fund, which should address the need for the Fund to assist with departmental operations, as well as recommendations on how the fund should be managed.

I FURTHER MOVE that the Council request the City Attorney, with the assistance of the CAO and CHRED, to prepare and present an ordinance to establish the Civil Rights Trust Fund.

### **ENERGY & ENVIRONMENT**

Across the City, many brownfields — properties with the presence of hazardous substances, pollutants, or contaminants – pose significant risks and safety hazards for the community. These conditions often occur on underused or abandoned properties formerly used for commercial or industrial uses, such as automotive repair shops, warehouses, dry cleaning facilities, and factories located in close proximity to schools, housing, and community amenities. While these brownfield sites no longer actively cause pollution, these facilities leave behind toxic chemicals and hazardous waste that continue to contaminate and pollute the air, water, soil, and wildlife in surrounding neighborhoods.

Many of these brownfield sites have proposed projects for redevelopment or reuse. However, the City currently lacks a formal clearance and intergovernmental notification process for brownfield sites with the California Department of Toxic Substance Control (DTSC) and any other County, State, and Federal agencies with jurisdiction over contaminated sites when a private applicant seeks City approvals. This is problematic, as environmental reviews are critical to ensuring redevelopment and reuse do not harm surrounding neighborhoods. It is essential that the City Departments, such as the Department of Building and Safety (LADBS), the Planning Department (DCP), the Bureau of Engineering (BOE), the Department of Sanitation (LASAN), the Los Angeles Fire Department (LAFD), and the Department of Transportation (LADOT) develop the permitting process systems to check with DTSC and other agencies with oversight of contamination issues for any potential impacts on proposed project sites.

Therefore, LADBS, DCP, and other Departments need to provide an overview and recommendations to enhance the existing brownfields permitting process, and in addition, any discretionary actions relative to the brownfields and the application status, certificate of occupancy, environmental clearance, vesting rights, and duration of any vesting rights permits issued, and how to report any permit/construction violations.

I THEREFORE MOVE that the Council instruct the Department of Building and Safety (LADBS), the Planning Department (DCP), the Bureau of Engineering (BOE), the Department of Sanitation (LASAN), the Fire Department and the Department of Transportation (LADOT), in consultation with the City Attorney, to prepare a report with the following recommendations:

- Require coordination with any County, State, or Federal agency with jurisdiction over contaminated sites, including but not limited to the Department of Toxic Substances Control, California Air Resources Board, and the Los Angeles Regional Water Quality Control Board, and creation of a clearance for the issuance of any permits for development projects on private property seeking to repurpose existing brownfield sites (i.e., contaminated sites listed on a State database) into other proposed land uses;
- Update City databases, such as but not limited to ZIMAS, with zoning information or overlay tools that can be
  used to identify brownfield sites to ensure appropriate clearances are included when developers are seeking a
  permit; and
- Revise the LADBS Information Bulletin "Procedures When Hazardous and Contaminated Materials are Encountered During Construction or Geotechnical/Geological Exploration" to reflect any changes.

The Go for Broke Monument in Little Tokyo is located on City-owned property at parking lot No. 2, which is bounded by Judge John Aiso and Temple Streets in Little Tokyo. # MOTION PLANNING & LAND USE MANAGEMENT

The Los Angeles Oil Field is one of the largest oil fields in the country. It spans over a thousand acres of land covering neighborhoods from Koreatown to Dodgers Stadium. In the early twentieth century, the City experienced an oil boom, producing nearly a quarter of the world's oil supply. However, as the population grew, the need for housing increased, which eventually led to the ramp down of onshore drilling rigs. Development began to surge on the oil field despite the lack of regulations and accountability measures to have operators properly plug and abandon these wells. This led to unsafe conditions throughout the City, including the recurrence of oil leaks, explosions, and spills.

Multiple areas in Los Angeles from the Downtown region to Wilmington are prone to leaking planet-warming methane and toxic air contaminants due to idle wells. Capping hazardous orphaned wells and addressing legacy pollution across our country will have a profound impact on our environment, our water quality, and the health and well-being of our communities. Today, the City has more than 5,000 active, idle, or abandoned oil and gas wells — the largest concentration of uncapped oil wells than any other oil field in the greater Los Angeles area. 1.7 million Angelenos live within one mile of an active oil or gas well. The close proximity of uncapped oil wells to residents, poses significant health hazards for residents. Exposure to the toxic chemicals such as methane, benzene, and other volatile organic compounds increase the risk of respiratory diseases and painful short-term symptoms. These chemicals not only threaten human health, but leave long-lasting soil, air, and water contamination and damage local ecosystems and habitats.

Although the City is working on addressing oil issues by phasing out production and exploring pathways to plug orphaned wells, there is still work that needs to be done around addressing oil leaks that occur with new developments and projects on the oil field.

WE THEREFORE MOVE the Council instruct the Board of Public Works' Office of Petroleum and Natural Gas Administration and Safety, with the assistance of the City Administrative Officer, and in consultation with, but not limited to, the Department of City Planning, the Fire Department, and the Department of Building and Safety, the City Attorney, and any Council office/Mayor's Office, to report on recommendations on instituting best practices relative to oil and gas uses in the land use regulatory process, in addition to solutions to protect the health and safety of residents from developments built over oil wells. The report should include the following information:

- An assessment of (1) existing City enforcement practices for oil and gas regulation for development/
  redevelopment and recommendations to augment enforcement efforts; (2) land use requirements for
  remediation on residential and commercial properties; and (3) identify accomplishments, challenges, and
  opportunities for improvement in the City's regulation of oil well site redevelopment;
- Recommendations on how to improve development standards to ensure developers fully locate any oil
  wells on a property;
- Analysis of all environmental reviews for development that occurs on or in close-proximity to active, idle, plugged and/or abandoned oil wells and recommendations to ensure these locations have adequate reviews before development occurs;
- Gather summaries of all existing methane mitigation requirements and all well abandonment standards
  from the Department of Building and Safety and the Fire Department and describe recommendations for
  additional City enforcement actions for when methane emissions leaks occur at these oil well sites;
   Research and determine the feasibility for design regulations and development standards for new
  construction in proximity to active, idle, plugged and/or abandoned oil wells. The research and feasibility

of the design regulations and development standards should include a discussion with regards to: new residential development near active oil well facilities including specific design standards to minimize exposure to any active oil well site operations (e.g. landscaping screening, enhanced air quality filter requirement);

- Research and determine the feasibility of a potential process to require ongoing methane gas monitoring for
  new multi-family residential buildings developed on oil well properties following a Certificate of
  Occupancy for the development. This would also include the feasibility of requiring quarterly reports by the
  property owner related to methane alarm activity and methane gas measurements for the multi-family
  development;
- Develop a Citywide oil well advisory notice embedded in ZIMAS and establish appropriate distance
  regulatory controls to guide development in close proximity to active, idle, plugged and/or abandoned oil
  wells. The notice should include a description of the potential safety, environmental, and public health risks
  associated with redevelopment on or adjacent to oil well sites, potential design and constructions standards
  for when an oil well site is redeveloped, and a list of responsible agencies to contact in case of oil well
  nuisance concerns;
- Create accountability measures for developers and property owners to ensure developments protect the
  health and safety of future and current occupants, and surrounding neighbors; and place owners and
  operators who are not in compliance with any existing and newly developed land use regulatory controls on
  a Monitoring Plan;
- Create a proposal to update any City related oil expert bench to include an expert on historic wells in order
  to comply with the City's existing development regulations and recommendations to ensure developers use
  historic oil experts;
- Recommendations creating a Citywide standard procedure to report new discoveries of historic and buried oil wells, to the California Geological Energy Management Division (CAL GEM);
- Create recommendations to integrate community input and expertise on site history that may not be
  captured by existing Cortese List databases (e.g. Department of Toxic EnviroStor or other databases),
  including but not limited to community meetings and listening sessions for new development; and,

• Develop a process to inform local constituents and community residents about oil spills in their neighborhoods that are commercially feasible in existing oilfield practices.

For many years, the City of Los Angeles has had a stated goal of completing a continuous bicycle and pedestrian path along the Los Angeles River from its headwaters in Canoga Park, across the San Fernando Valley, through the Sepulveda Basin, Griffith Park, Elysian Valley, and beyond. The City is the lead agency for the unbuilt segments across the San Fernando Valley from Reseda to Griffith Park (the "Valley LA RiverWay"); Metro is the lead agency for the unbuilt segment south of Figueroa Street. As part of the City's effort to complete the Valley LARiverWay, the Bureau of Engineering has finalized the design of a critical segment: three (3) miles from Vanalden Avenue in Reseda to Balboa Boulevard in the Sepulveda Basin. Completion of this Project is a top priority for the City.

Most importantly, completion of the Valley LA RiverWay is a voter-approved Measure M project. In 2016, when Metro and City leaders asked the voters to approve a ½-cent sales tax in perpetuity for transportation, Metro and the San Fernando Valley Council of Governments included the Valley LARIverWay in the official Expenditure Plan. Los Angeles County voters overwhelmingly approved Measure M, and Metro and the City have an obligation to keep their word to the voters by providing the transportation projects they promised.

It is important to complete this Project as soon as possible. In less than four years, the City will host the 2028 Olympic and Paralympic Games. To truly make these Games a Citywide event, the Los Angeles Organizing Committee (LA28) and the City approved a Venue Plan that calls for holding events in the Sepulveda Basin. This Project leads directly to that venue. LA28 has proposed, and the City is considering, changes to the Venue Plan that would move BMX and skateboarding events to the Sepulveda Basin. The City has announced that it seeks to make the LA28 Games as car-free as possible. To accomplish that goal, the City must provide safe, convenient and efficient ways to access venues by active transportation. People who are fans of bicycling and skateboarding events would most likely be receptive to using alternative modes of transportation. For that reason, completion of this Project is a natural fit for the City's 2028 Games planning.

The Project has secured significant funding, including a \$19.6 million grant through the State's Active Transportation Program. Nevertheless, a significant funding gap remains. When the City applied for and accepted the ATP grant, it was entitled to construction funding in FY22-23. The City is now two years behind that schedule. Further delays in this Project could jeopardize the ATP grant. A significant funding gap remains, which has led the City to delay issuing an RFP for the Project. As construction costs continue to escalate, further delays only increase that gap.

I THEREFORE MOVE that the City Council instruct the City Administrative Officer, and request the Mayor, to make completion of the Valley LARiverWay segment from Vanalden Avenue to Balboa Boulevard, in advance of the 2028 Olympic and Paralympic Games, a top budget priority and an integral part of the City's transportation plans for the 2028 Olympic and Paralympic Games.

The area of Panorama City and North Hills, bounded by Roscoe Boulevard, I-405, Plummer Street, and Van Nuys Boulevard, is a high-density community in the East San Fernando Valley undergoing significant growth. With numerous multifamily developments under planning and construction, this area serves a diverse population, including a high concentration of lower-income renters. However, the aging infrastructure is ill-equipped to support the expanding population, making it difficult for new developments to connect without costly and time-consuming upgrades. These challenges not only raise project costs but also place additional burdens on City departments struggling to keep up with new demands.

Currently, the City's infrastructure planning lacks a coordinated approach with clear criteria that balance technical requirements alongside equity and community needs. The absence of an equity-focused Capital Improvement Plan (CIP) leaves historically underserved areas like this at heightened risk of service disruptions and public health issues. Without deliberate investment, infrastructure deficiencies will persist, making it difficult to support affordable housing, economic growth, and the well-being of current and future residents.

To effectively address these issues, creative solutions must be considered, particularly when integrating new infrastructure into an older system. One important opportunity is the inclusion of stormwater management improvements as part of infrastructure upgrades in this area. Given the density and lack of open space in this area, it is critical that new developments and infrastructure projects incorporate sustainable stormwater solutions to mitigate runoff and enhance the resilience of the community against future climate impacts. By addressing both the water and sewer needs alongside stormwater improvements, we can develop a more holistic and equitable approach to infrastructure investment.

The Bureau of Sanitation and the Bureau of Engineering, in coordination with the Los Angeles Department of Water and Power, should conduct a comprehensive assessment of the water and sewer systems in this specific area, considering both the current condition of the infrastructure and its ability to handle the expected future growth. An equity-focused approach is necessary to ensure that this area, which has historically seen fewer public investments, receives the attention and resources needed to support sustainable growth and a healthy living environment.

I THEREFORE MOVE that the Bureau of Sanitation and Bureau of Engineering, in coordination with the Department of Water and Power, be instructed to report to the City Council within 180 days on the state of water and sewer infrastructure in the area bounded by Roscoe Boulevard, the I-405 freeway, Plummer Street, and Van Nuys Boulevard, including:

- Conduct a comprehensive evaluation of the current water and sewer system capacity, condition, and
  performance within the area bounded by Roscoe Boulevard, the I-405 freeway, Plummer Street, and
  Van Nuys Boulevard, with particular attention to areas with past drainage and/or flooding issues and
  any existing plans for facility upgrades and expansions.
- Analyze the ability of the existing infrastructure to support current and anticipated growth in the area, especially given the rise in multifamily and commercial developments, and provide recommendations for additional study or development where necessary.
- Develop and propose creative solutions to address both water and sewer infrastructure needs, including but not limited to new catch basins, incorporating stormwater management improvements wherever possible to mitigate runoff and increase community resilience.

- 4. Include an assessment of recent 311 data specific to water and sewer service requests in this area to identify recurring issues and trends that may inform infrastructure planning.
- Coordinate with Council District 6 to actively gather additional community input on water and sewer-related concerns, ensuring a comprehensive record of local issues that may impact infrastructure planning and prioritization.
- 6. Prioritize the advancement of the pending stormwater capture projects at the Sepulveda Recreation Center and North Hills Park, and integrate these projects as key components of the broader infrastructure improvement strategy for this area.
- 7. Investigate the purpose and function of the trenched concrete channel along Parthenia Avenue, between Burnet and the Pacoima Wash, examining how it may be incorporated into future infrastructure projects to enhance stormwater management or community resilience.
- 8. Provide a detailed account of Bureau of Sanitation's internal project selection and prioritization process for sewer-related capital planning, including the criteria used to evaluate and advance projects, ensuring transparency and alignment with community needs and infrastructure objectives for this region.

The LA2050 Grants Challenge is an open call for ideas to make Los Angeles County the best place to connect, create, learn, live, and play. Since 2013, LA2050 has launched 11 cycles of the LA2050 Grants Challenge, giving more than \$11M to 155 local social impact organizations. The Department of Neighborhood Empowerment (DONE) submitted a grant application to LA2050 under the "Connecting Neighbors & Empowering LA!" initiative. This initiative strengthens neighborhoods by fostering connections, enhancing community spirit, and encouraging individuals to invest their time and skills for the improvement of their local area.

The Department's application was accepted and LA2050 announced that a grant of \$50,000 has been awarded to the DONE. Pursuant to Los Angeles Administrative Code Section 14.6 et seq, the application was submitted without prior Council approval due to this being a competitive grant and the Department being made aware of this opportunity with less than 30 days of advance notice of the application deadline. The grant will be used to host up to eight neighborhood events in the South, Central, East, and Harbor regions of Los Angeles, and the San Fernando Valley. In collaboration with City departments and regional partners, the neighborhood events will feature tabling opportunities and workshops/trainings with the goal of signing up volunteers to participate in local improvement projects and join Neighborhood Councils.

I THEREFORE MOVE that the Council authorize the Department of Neighborhood Empowerment (DONE) to submit a grant application to and accept a grant award from LA2050 for the "Connecting Neighbors & Empowering LA!" initiative in the amount of \$50,000.

I FURTHER MOVE that the Council authorize the DONE General Manager, or designee, to conduct all negotiations, execute, and submit all documents, including but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the acceptance and use of LA2050 grant funds.

I FURTHER MOVE that the Council authorize the Controller to establish and appropriate a new appropriation account entitled "Department of Neighborhood Empowerment - LA2050 Grant" within the Neighborhood Empowerment Fund No. 44B, Department 47, Account No. 47A237.

I FURTHER MOVE that the Council authorize DONE to accept and deposit the awarded \$50,000 into the "Department of Neighborhood Empowerment - LA2050 Grant" within the Neighborhood Empowerment Fund No. 44B, Department 47, Account No. 47A237.

I FURTHER MOVE that the City Council instruct DONE to track the use of all LA2050 grant funds and report with an accounting of the funds, the lessons learned, and any obstacles faced, as well as highlight any changes in scope of services that differ from the initially approved scope of services for the grant funds.

I FURTHER MOVE that the City Council authorize the City Administrative Officer to make any technical corrections or clarifications to the above fund transfer instructions in order to effectuate the intent of this Motion and authorize the Controller to implement these instructions.

### PUBLIC SAFETY

### MOTION

As electric vehicles (EVs) become more common on our City streets, the Los Angeles Fire Department faces a new challenge in responding to incidents with these vehicles. EV fires differ from traditional internal combustion engine (ICE) vehicle fires due to the properties of lithium-ion batteries.

One of the difficulties in handling EV fires is the process of thermal runaway, a chemical process that is not as easily extinguished as a gasoline fire in part because it doesn't require oxygen. This results in sustained high-temperature fires that are difficult to extinguish, prone to re-ignition, and sometimes take hours or even days to be completely extinguished.

Another complication is the location and design of EV batteries. Encased in protective structures and often mounted beneath the vehicle, EV batteries are difficult to access with conventional firefighting equipment and limit firefighters' ability to target the source of the fire. Additionally, EV fires often release toxic gases that pose health risks to responders and may require the use of self-contained breathing apparatus (SCBA).

As EV usage continues to rise, the Los Angeles Fire Department must take proactive steps to ensure that they are best equipped to handle these incidents. This includes not only acquiring the right tools, but also creating training materials for members of the Department.

I THEREFORE MOVE that the Fire Department report back with an assessment of equipment needed to mitigate electric vehicle (EVs) fires. This report should include the following information:

- Tools and equipment the Department currently has to address EV fires; and
- Additional tools or resources, with associated costs, needed to enhance the Department's capability to manage EV fires;

I FURTHER MOVE that the Fire Department report back with a training program that will help prepare Department personnel handle EV fires. This report should also include response protocols for EV fires that may differ from internal combustion engine (ICE) vehicle fire responses.
