Roll Call #2 - Motion (Smith - LaBonge) to Adopt as Amended, Ayes (10); Absent: Cardenas, Parks, Perry, Weiss and President Padilla (5)

00-1073 - PUBLIC WORKS COMMITTEE REPORT relative to a revised draft Ordinance amending S2 Los Angeles Municipal Code (LAMC) Section 42.00 (f) - Newsracks.

Recommendations for Council action:

1. REQUEST the City Attorney to prepare and present a draft ordinance amending LAMC Section 42.00 (f) - Newsracks, substantially as attached to the Chief Legislative Analyst (CLA) report dated February 13, 2004, and amended as follows:

- a. Implementation Extensions Publishers experiencing financial hardship, due to compliance with LAMC Section 42.00 (f), may request the Board of Public Works (BPW) to grant up to two one-year extensions, if proof of financial hardship is proven to the satisfaction of the BPW.
- b. Maintenance The newsrack permittee shall maintain all newsracks and the sidewalk surface immediately under and adjacent (within five feet) to the newsracks in a safe, clean, attractive, and sanitary condition and in good order and repair, as determined by the Bureau of Street Services (BSS). The permittee shall make routine inspection and maintenance calls on each newsrack once a week.
- c. Maintenance Response Time Permittee shall respond to a request to secure a site or perform maintenance within 24 hours of notification, but in no event more than 72 hours.
- d. No Newsrack Areas In the event any future area of the City which has been deemed by the City Cultural Heritage Commission and the Council to be of municipal or regional historic significance, such an area may apply with the BPW for designation as an area where no newsracks shall be installed, subject to approval by the Council.
- e. Newsrack Placing Restrictions Retain placement restrictions set forth in the existing ordinance, with the exception of adding Americans with Disabilities Act standard four-foot clearance which covers outdoor dining areas, art, historical or cultural landmarks, etc. In addition, prohibit newsracks within 20 feet of public art, or historical cultural landmarks. Cultural Heritage Commission decisions may be appealed to the BPW.
- f. Color All newsracks shall be ivy green. Within Specific Plan Areas, Streetscape Plan Areas, and other Special Planning Districts, a different color may be chosen. If a color other than ivy green is specified, the BPW, with Council input, will determine the newsrack color from a three-color palette of black, blue (Westwood area RAL Number to be specified), and gray (Wilshire area Marine Silver 38/90010).
- g. Implementation Period Six months for permitting, blight, and public hazard issues; 12 months for spacing, rack card, and logo issues; and, 36 months for color and all other issues.
- 2. INSTRUCT the BSS to report on the feasibility of allowing more that one publication to be distributed out of a single newsrack.

<u>Fiscal Impact Statement</u>: The CLA reports that approval of the proposed recommendation will not authorize personnel and related costs necessary for the administration and enforcement of the provisions of this ordinance. Approval also does not institute an initial annual or renewal fee for newsrack permitting, which may be established at levels to recover all, or a portion of, General Fund costs and will be established through separate action.

Community Impact Statements:

- 1. The Hollywood Hills West Neighborhood Council (HHWNC) reports that on September 18, 2003, its Board voted in favor of strengthening the newsrack ordinance to regulate the aesthetic quality of all newsracks placed on City sidewalks and to establish placement criteria. Consistent with its efforts to improve the aesthetics of its Hollywood neighborhood, the HHWNC Board wishes the new ordinance would lessen the visual clutter created by the preponderance of newsracks in all shapes, colors, and sizes.
- 2. The Greater Griffith Park Neighborhood Council (GGPNC) reports that due to the recent proliferation of unsightly and illegal newsracks, it strongly supports amending the existing, California Supreme Court tested, ordinance to include: permits, fines, and bar codes for enforcement. The amended ordinance should certainly not grandfather newsracks that have been blatantly and illegally installed. The City should never reward bad faith behavior. The GGPNC supports the recommendations of the Coalition for L.A.'s Enforcement Applied to Newsracks (CLEAN). The GGPNC Board was made aware of CLEAN's position papers, and because of the blight in the GGPNC community, voted by consensus to support CLEAN's recommendations.

Furthermore, Publishers experiencing financial hardship, solely due to compliance with LAMC §42.00 (f) as it applies to uniform color, may request the Board to approve up to two (2) 12 month extensions allowing them a total of 36 months to come into full compliance with the Newsrack Ordinance.

Recommendations for Council action:

- REQUEST the City Attorney to prepare and present an ordinance, substantially as submitted by the Department of Public Works, Bureau of Street Services (BSS) (attached to the BSS report dated July 2, 2003) amending Section 42.00 (g) (3) of the LAMC which will increase the allowable size of newsstands, allow for advertising, and modify certain installation requirements.
- 2. AUTHORIZE the BSS and Viacom Decaux, LLC to proceed with newsstand kiosk installation prior to adoption of an amending ordinance which will increase the allowable size of newsstands, allow for advertising, and modify certain installation requirements.

<u>Fiscal Impact Statement</u>: The BSS reports that failure to proceed with the contract's projected rollout schedule will cause the City to be at fault for delays pertaining to its contractual obligations, which in turn will adversely affect guaranteed City revenues for the current calendar year.

 - a. County agencies will be compiled into a database by City staff working with the County Recycling Coordinator. City staff will contact the agency to ascertain whether they have implemented the County's white paper recycling program and assist them in starting programs to recycle other materials that they currently dispose.
 - b. State Agencies, since they are already required to reduce and recycle waste as well as provide annual reports to the California Integrated Waste Management Board (CIWMB) on their progress, will be monitored periodically for compliance through the CIWMB State Agency Assistance Section, and that City staff provide outreach materials if necessary to assist in finding recycling services.
 - c. Federal facilities and offices in Los Angeles will be compiled into a database by City staff working with the Federal General Services Administration. City staff will contact large federally owned and leased facilities to establish the amount of recycling currently occurring at these facilities. After establishing a baseline, City staff can assist local Federal staff in beginning or expanding waste reduction and recycling programs.
 - d. The Bureau of Sanitation will continue to assist the Los Angeles Unified School District in increasing its recycling rate by providing upon request, the ability to recycle mixed paper collected by students at elementary schools, and providing bins for the collection of beverage containers at middle and high schools.

2. INSTRUCT the Bureau of Sanitation to report back to the Environmental Quality and Waste Management Committee within 90 days with a status report on its efforts in this endeavor.

<u>Fiscal Impact Statement</u>: None submitted by the Bureau of Sanitation. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.
