<u>Fiscal Impact Statement</u>: The City Administrative Officer reports that the MOCJP has identified \$2,638,750 in available funding that can be used to implement year seven of the CLEAR program. A total of \$2,483,750 is from a new Department of Justice, Bureau of Justice Assistance grant, and \$155,000 is rollover funding from prior year CLEAR budget savings.

The total cost of program participation requires significant in-kind resources from both the LAPD and the City Attorney's Office to exceed the available grant funding.

The grant will reimburse the City \$275,582 to partially offset the salaries for ten positions in the LAPD. The approximate annual salary cost for these positions is \$904,959. The remaining balance of approximately \$629,377 is a General Fund obligation that has already been factored into the LAPD's 2003-04 salary base. The grant will also reimburse the LAPD \$368,470 for sworn overtime costs.

The grant will reimburse the City \$343,149 to partially offset the salaries for four positions in the City Attorney's Office. The approximate annual salary cost for these positions is \$396,272. The remaining balance of approximately \$53,123 is a General Fund obligation that has been factored into the City Attorney's Office's 2003-04 budget.

The grant will also reimburse the City \$50,000 to partially offset the salary of one position in the MOCJP. The approximate annual cost of this position is \$64,556. The remaining balance of approximately \$14,556 will be made up by funding for other criminal justice program grants.

The total annual lease rate for 2.0180 acres is approximately \$151,350.50. The LAWA wants the City to maintain an extra 0.1068 acre landscape strip at the City's cost. The City will create a zero landscape strip. The \$151,350.50 would have to be included in the budget for Fiscal Year 2004-05. Funding for five or six months of this fiscal year will have to be identified. The monthly cost is \$12,612.50 per month for the ground lease. The LAWA transfers funds for the services of LAFD at LAWA sites to the City's General Fund Receipt Account, Source Code No. 419, Quasi-External Transactions. The Lease costs would have to be transferred from this fund or the Unappropriated Balance of the General Fund to GSD's 6030 Leasing Account.
