<u>Fiscal Impact Statement</u>: The CDD reports that funding for projects specified in this transmittal comes from the 2006-07 CDBG and, also, from the CSBG (which include allocations from the actual 2006 and projected 2007 awards), except for part of the Day Laborer Program. An application for GCP funds for the Day Laborer Program was submitted and the annual program budget shown in Attachment B of the CDD report includes a projected \$329,734 in 2006-07 GCP funds. Actual allocation of 2006-07 GCP funds is not known at this time. If GCP funds are not allocated to the Day Laborer program, the CDD will report back to the Mayor and Council for direction on applying the funding reduction to the entire program.

Similarly, should anticipated 2007 CSBG funding to support the Human Services Delivery System be reduced or eliminated, CDD will report back to the Mayor and Council for direction on the scope and application of the reduction to the Human Services Delivery System. City agreements that would be amended pursuant to actions recommended in this transmittal contain language stating that funding for all periods of the agreement is subject to the continuing availability of federal funds for the program to the City.

Funding for the projects specified in this transmittal come from the 32nd Year Consolidated Plan. This action will not impact the General Fund.
