City Clerk administrative expenses will be charged to the proposed PBID and will be recovered from assessments collected. The amount of recoverable costs for the first year of the proposed PBID's operations is estimated to be \$4,437.63 or five percent of the proposed PBID's estimated first-year assessment revenue. If the PBID's assessments are not placed on the County's annual property tax rolls, an additional one percent for processing of direct billing by the City Clerk's office will apply.
