A. BUDGET AND FINANCE COMMITTEE REPORT

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. INSTRUCT the Community Development Department (CDD) with regard to funding of CBDO-ineligible agencies and CBDO agencies pending certification to:
 - a. Fund all CBDO-ineligible agencies as well as those with the capability of being CBDO-certified, for services incurred through approximately September 30, 2006.
 - b. Immediately serve agencies with a 30-day notice of termination of services as per City contracting provisions.
 - c. Exchange on a dollar for dollar basis CDBG funds allocated in the 32nd Program Year Consolidation Plan under the CBDO category in the amount of \$2,147,677 from a total of up to \$6,081,005 in committed project funds from the Urban Development Action Grant (UDAG) Revenue Fund (with the flexibility to utilize other appropriate UDAG projects as identified by the CDD), and allow the CDD to review the use of General Fund dollars for additional potential dollar for dollar exchange.

- INSTRUCT the CDD with regard to funding of agencies with capacity to be CBDOcertified to:
 - a. Provide a notice that explains CBDO status, options for compliance and a requirement to reply to the City within 30 *90 days of intent to comply, and 30 days thereafter to meet all requirements for certification.

*(Huizar - Parks)

- b. Enter into 12-month contracts with agencies only upon CBDO certification.
- c. Report back in 40 days with the outcome of these efforts, including a list of agencies moving forward with the process, services covered and potential service gaps, and an update on alternative funding sources, including UDAG Revenue Fund sources identified in the CAO's report dated July 28, 2006, and potential impacts on the General Fund.
- 3. REQUEST all Council Offices contact agencies within their respective districts, particularly those agencies pending certification, and assist and encourage them to review the matter and respond to the CDD in an expeditious manner.
- 4. INSTRUCT the General Manager, CDD, or designee, to:
 - a. Process the necessary Substantial Amendments to the Consolidated Plan, inclusive of all other Housing and Urban Development (HUD) and federal requirements such as citizens participation process, pursuant to any exchanges of funding with CDBG as a result of the Mayor and Council actions on this matter.
 - b. Report back with a sustainability plan for public services providers beyond 2006-07 that will not have an impact on the General Fund, thus complying with City Financial Policies, inclusive of re-issuance of a Request for Proposal (RFP) for 2007-08 to comply with funding available in the Consolidated Plan and other grant sources for the provision of public services.
- 5. AUTHORIZE the General Manager, CDD, or designee, to prepare Controller instructions for any technical adjustments that may be necessary and are consistent with the Mayor and Council action on this matter, subject to the approval of the City Administrative Officer (CAO), and AUTHORIZE the Controller to implement those instructions.
- 6. REQUEST the Mayor's Office to report back to the Council relative to legislative strategy for addressing the City's CBDO certification and Public Services CAP issues in general.
- 7. INSTRUCT the CAO and the Chief Legislative Analyst (CLA), with the assistance of the CDD, to report back to the Council relative to potential funding sources for an additional six months funding, including the Capital Improvement Expenditure Program, Assembly Bill 1290 funds, Reserve Fund loan and other sources, for both ineligible and agencies with capacity to be certified.

- 8. REQUEST that the CAO, CLA and City Attorney prepare and present a policy relative to the funding and certification of CBDOs.
- 9. AUTHORIZE the CDD to enter into contracts with CBDO-certified subsidiaries that are established pursuant to matters addressed in this Council action, subject to the approval of the City Attorney as to form and legality, with names and other identifying information of such subsidiaries to be provided to affected Council offices and transmitted to the Council File.
- 10. AUTHORIZE the Controller to accept from the CDD a list of subsidiary providers for which to provide payment upon verification of CBDO certification.

<u>Fiscal Impact Statement:</u> The CAO reports that this action does not comply with City Financial Policies in that one-time exchanges of grant funding sources are provided to an otherwise ongoing provision of public services, unless such services are scaled down to conform with available Consolidated Plan and other grant funding in those ensuing budget processes.

 - a. Provide a notice that explains CBDO status, options for compliance and a requirement to reply to the City within 30 days of the intent to comply, and 60 days thereafter to meet all requirements.

- b. Enter into 6-month contracts with agencies immediately (from funding source that is not subject to CBDO requirements), that will extend to 12-month contracts only upon CBDO certification.
- c. Instruct CDD to report back in 40 days with the outcome of these efforts, including a list of agencies moving forward with the process, services covered and potential service gaps, and an update on alternative funding sources, including UDAG Revenue Fund sources identified in this report, and potential impacts on the General Fund.
- 3. AUTHORIZE a Reserve Fund loan for the appropriate amount contingent on Mayor and Council policy decisions with regard to the following, on the basis that exchanges of committed and/or expended UDAG or other non-Community Development Block Grant (CDBG) funds for CDBG/CBDO funding may require grantor approval and/or is subject to federal requirements governing the grant source:
 - a. Twelve-month funding for all CBDO-ineligible agencies: \$4,295,354.
 - b. Twelve-month funding for all potentially CDBG-eligible agencies, subject to compliance of certification requirements: \$11,149,112.
- 4. INSTRUCT the General Manager, CDD, or designee, to:
 - a. Process the necessary Substantial Amendments to the Consolidated Plan, inclusive of all other HUD and federal requirements such as citizens participation process, pursuant to any exchanges of funding with CDBG as a result of the Mayor and Council actions on this matter.
 - b. Report back with a sustainability plan for public services providers beyond 2006-07 that will not have an impact on the General Fund, thus complying with City Financial Policies, inclusive of re-issuance of a Request for Proposals for FY 2007-08 to comply with funding available in the Consolidated Plan and other grant sources for the provision of public services.
- 5. AUTHORIZE the General Manager, CDD, or designee, to prepare Controller instructions and any technical adjustments that may be necessary and are consistent with this action, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE that the Controller to implement those instructions.
- 6. REQUEST the Chief Legislative Analyst, CAO, and City Attorney to prepare and present a policy relative to the funding and certification of CBDOs.
- 7. AUTHORIZE the CDD to enter into contracts with CBDO-certified subsidiaries that are established pursuant to matters addressed in this Council action, subject to the approval of the City Attorney as to form and legality, with names and other identifying information of such subsidiaries to be provided to affected Council offices and transmitted to the Council file.

8. AUTHORIZE the Controller to accept from CDD a list of subsidiary providers for which to provide payment upon verification of CBDO certification.

Fiscal Impact Statement: The CAO reports that the recommendations of its report to the Mayor and Council dated July 28, 2006 (attached to the Council file) require a Reserve Fund loan of up to \$6.7 million as security for funding commitments to CBDO-ineligible providers that will involve an exchange of grant funds which are subject to grantor approval; and, up to an additional \$8.8 million for funding commitments to providers that have capacity to be CBDO-certified but for which such determinations cannot be made until providers have complied with federal requirements. This action does not comply with City financial policies in that one-time exchanges of grant funding sources are provided to an otherwise ongoing provision of public services, unless such services are scaled down to conform with available Consolidated Plan and other grant funding in those ensuing budget processes.
