The minimum total revenue to the Airport Revenue Fund will be \$1,013,588 annually or \$20,271,760 exclusive of adjustments or increases over the remaining 20-year term. In addition, the LAWA will receive a one-time payment of the retroactive rent past due of \$162,891 for a total projected additional revenue of \$20,434,651.

Fiscal Impact Statement: The City Administrative Officer reports that since the LAWA is only bound by the City Debt Management Policies, the City Financial Policies are not applicable. Revenue to the Airport Revenue Fund will total \$331,337 with increasing annual rate adjustments anticipated during the term of the lease and a one-time purchase amount of \$850,000 of the City-owned Hangar/Office Complex in the first year.

PUBLIC SAFETY and BUDGET AND FINANCE COMMITTEES' REPORT and COMMUNICATION FROM CHAIR, PERSONNEL COMMITTEE relative to a supplemental grant award for the Internet Crimes Against Children Task Force Program.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the Chief of Police to accept the \$400,000 supplemental grant award from the Department of Justice, Office Juvenile Justice and Delinquency Prevention (OJJDP) for the Internet Crimes Against Children (ICAC) Task Force Program.
2. AUTHORIZE the Chief of Police to execute the grant agreement with OJJDP on behalf of the City from December 1, 2003 through September 30, 2007 and submit documents relative to the grant, subject to review and approval of the City Attorney as to form and legality.
3. AUTHORIZE the Chief of Police to negotiate and execute agreements with the following agencies: Glendale Police Department; Pasadena Police Department; Torrance Police Department; Redlands Police Department; San Bernardino County Sheriff's Department; and two as of yet unidentified law enforcement agencies in Los Angeles County or its adjacent counties, subject to review and approval of the City Attorney as to form and legality.
4. AUTHORIZE the Chief of Police to select up to two other law enforcement agencies from the County of Los Angeles or its adjoining counties to participate in the Los Angeles ICAC Task Force Program and/or replace existing members that may wish to withdraw from the Task Force, based on the following criteria:

- a. Ability to commit designated staff to the ICAC Task Force to maximize return on training resources invested.
 - b. Ability to commit staff to conduct ICAC Task Force investigations on a regular and on-going basis.
 - c. Ability to comply with ICAC Task Force Program rules, requirements, and investigative best practices.
 - d. Consideration of geographic diversity and populations in making a selection among agencies that illustrate the equivalent ability to comply with the above criteria.
5. AUTHORIZE the Los Angeles Police Department (LAPD) to expend \$64,798 for grant-related expense and equipment items in the following amounts:
- a. Equipment in the amount of \$37,912
 - b. Supplies in the amount of \$6,280
 - c. Lease of copier in the amount of \$1,616
 - d. Other services in the amount of \$18,990
6. AUTHORIZE the LAPD to expend \$17,775 for grant-related training and/or travel.
7. AUTHORIZE the LAPD to disburse an aggregate total of \$35,000 for the reimbursement of overtime costs and to disburse an aggregate total of \$21,078 for the reimbursement of training and/or travel costs to the law enforcement agencies identified below that are or will be participating in the Los Angeles ICAC Task Force Program.
- a. Glendale Police Department
 - b. Pasadena Police Department
 - c. Torrance Police Department
 - d. Redlands Police Department
 - e. San Bernardino County Sheriff's Department
 - f. As yet unidentified law enforcement agency in Los Angeles County or its adjacent counties
8. AUTHORIZE the LAPD to utilize \$261,349 in funding to pay for a portion of salaries and related costs for a Detective II and two Police Officer II positions.
9. RESOLVE that the continuing Employment Authority for one position of Detective II, Class Code No. 2223-2, for the period July 1, 2006 through June 30, 2007 is APPROVED.
10. RESOLVE that Employment Authority for two positions of Police Officer III, Class Code No. 2214-3, through June 30, 2007, subject to proper allocation by the Personnel Department and paygrade review by the City Administrative Officer (CAO) is APPROVED.
11. AUTHORIZE the LAPD to receive and expend the current grant funds for grant program

purposes, consistent with the grant award and grant budget, and deposit those funds in the grant trust fund for expenditure or reimbursement to the General Fund, as appropriate.

12. TRANSFER \$138,651, as a reimbursable advance, from the Reserve Fund to the Unappropriated Balance and APPROPRIATE a like amount therefrom to the LAPD Grant Fund No. 339/70, Account No. A415.
13. INSTRUCT the LAPD to transfer grant receipts from Fund No. 339/70, Account No. A415 to Fund No. 670/70, Account No. A002 for the reimbursement of any ICAC grant-related travel costs.
14. AUTHORIZE the LAPD to prepare Controller's instructions for any necessary technical adjustments, subject to the approval of the CAO, and AUTHORIZE the Controller to implement the instructions.

Fiscal Impact Statement: The CAO reports that although the ICAC supplemental grant award will not pay for the full costs of the positions associated with this program, the LAPD has indicated that the additional costs can be absorbed by existing funds within their sworn salary account. Therefore, approval of the recommendations is in compliance with the City's Financial Policies.
