 - b. Report back to the Planning and Land Use Management Committee within 60 days detailing the progress of needed revisions to the Plan Check and Information System/ Clearance Summary Worksheet System relative to the inclusion of appropriate fields for the LAHD Certificate of Occupancy sign-off.
