While the Mayor's Proposed Reserve Fund is modestly increased compared to the current fiscal year, in total (from \$186M to \$187M), the Emergency Account of the Fund is reduced (from \$108M to \$89M). During the budget discussions, the Committee's first priority was to restore the Emergency Account of the Reserve Fund, at a minimum to its actual level of \$108M on July 1, 2006. List of all current employees, by name, on the department payroll during the report period, including classification. Monthly reporting identifying changes from the prior period will be highlighted.

Measurable outcome and annual goals for each program/function that canb e used to evaluate performance. Include a monthly plan to achieve annual goals. An analysis of department's actual performance during the report period, by program/function in measurable units, as compared to monthly plan/annual goals, an explanation for any deviations and submission of a corrective action plan. These outcomes/goals will be developed in collaboration with the departments.

An annual plan for revenue generation by : Department, program, source/license/or fee name; annual dollar collection goal with monthly target amounts; reporting period revenue generation by program, source/license/or fee name compared to monthly target and cumulative collections for the fiscal year; explanation for any deviations from plan; and corrective action plan.

Adopted Budget, subsequent amendment, if any; reporting period expenditures, by program and account; fiscal year cumulative expenditures by program and account; deviations from plan, based on projections and explanation for any deviation, and corrective action plan.

- b. Instruct the CAO and CLA, with assistance of the City Attorney, to report back no later than July 1, 2007, regarding incentives that may be instituted for General Managers to manage departments within budget and to achieve expected program outcomes including, but not limited to: Merit pay review (in conjunction with the Mayor); more regular reporting to Budget and Finance Committee; stricter budgetary controls; and opportunities/penalties to carry forward surpluses/deficits through reappropriations/reductions in future year budgets.
- c. Instruct the CAO and Personnel Department to report back to Budget and Finance Committee by no later that July 1, 2007 on a protocol for monitoring department requests for certification from eligible lists to ensure that the filling of vacancies will not result in the respective department exceeding its 2007-08 Budget.

Revenue: Actual revenue collections; projections of potential shortfalls or surplus revenue, as compared to the Budget; date on which adjusted fees became effective; departments which have not submitted ordinances necessary to implement adjusted fees included in Adopted Budget; and recommendations for remedial action to achieve revenue projections, if necessary.

Expenditures: Actual expenditures by department and program; comparison to expenditure plan; recommendations for any remedial action necessary to remain within budget.

Highlight departments' overtime usage including detail, by department, the purposes (function/program, etc) for which overtime was expended; the dollar amount and number of hours expended for each purpose; dollar amount budgeted vs. dollar amount remaining for the fiscal year; any projected shortfalls or surpluses based on actual experience.

Programmatic or functional outcomes: Actual outcomes, by department, program or function during the reporting period, as compared to plan; an analysis of any deviation and recommendation for remedial action, as necessary.

Personnel hiring, by department, actual vs. authorized, net of positions to be held vacant in order to achieve budgeted savings. Also include the number hired, classification and activity/program to which personnel are assigned.

- h. Hold semi-annual budget hearings, similar to those held during its annual consideration of the Proposed Budget, focusing on departments in jeopardy of over expending budget allocations and those departments which are not achieving outcomes and anticipated by the Council.
- i. Request the Airports, Harbor, Water and Power and CRA to report to the Budget and Finance Committee by September 2007, with their adopted financial policies, using the City's Financial Policies as a model. Highlight areas in which there may be inconsistencies with the City's Financial Policies, including explanations as to why an identical policy may not be feasible.
- j. Instruct the CAO, with assistance of the CLA, to report to the Budget and Finance Committee by September 2007 with Fee Subsidy Policies for Special Events and the Los Angeles Convention Center, patterned after the Development Fee Subsidy Policy.
- k. Instruct the CAO and CLA to report to the Budget and Finance Committee with a concept for an "baseline budget program" for purposes of long-term planning, removal of the risk of revenue shortfalls and incurring on-going expenditures without an identified source of funds.
- I. Instruct the CAO to report to the Budget and Finance Committee with a Capital Program Financing Policy for purposes of long-term planning and budgeting. Review all delayed/deferred capital maintenance and repair needs for incorporation into this policy.
- m. Recommend that preparation of a Contingency Plan consisting of the following to address the imminent threat to telephone tax revenues (UUT):
