REQUEST the Board of Recreation and Park Commissioners to accept funds in an amount not to exceed \$2,282,116 from the CRA, deposit the funds, and appropriate as necessary pursuant to the terms of the Cooperation Agreement between the CRA and the DRP, subject to the execution of the Cooperation Agreement.

<u>Fiscal Impact Statement</u>: The City Administrative Officer reports that the impact on the General Fund is not known at this time. Approval of the recommendations will result in the expenditure of \$2,282,116 in AB 1290 funds from the CRA's RCRPA for the proposed Project. Upon construction completion, funding for ongoing pool maintenance costs will be subject to future appropriations by the Mayor and Council. The recommendations are in compliance with the City's Financial Policies in that a one-time expenditure of a General Fund department is an adjunct to a one-time source of funds from the CRA. The City's Financial Policies are not applicable to the CRA. The CRA is only bound by the disclosure provisions of the City's Debt Management Policies.
