- 4. TRANSFER \$410,000 from Fund 100/56 (GCP) Account 0857 (Citywide Special Events Fee Subsidy) to Fund 100/94 (Transportation) Account 1090 (Salaries Overtime) as a cashflow loan until payments are received from contracted special events and payments are made by special event sponsors for City fees and costs in accordance with the City's Special Event Fee Subsidy Policy.
- 5. INSTRUCT the City Administrative Officer, with the assistance of the City Clerk, to ensure that funds are reimbursed in full to Fund 100/56 Account 0857 (Citywide Special Events Fee Subsidy), as funds are made available from payments for City permit fees and staff costs by special events sponsors.
- 6. AUTHORIZE the City Clerk to make any technical corrections that may be necessary to accomplish the intent of this Motion.
