Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. APPROVE the recommendations of the City Administrative Officer (CAO) as stated in the November 4, 2009, report to the Mayor and Council (attached to the Communication from the Ad Hoc Committee on Economic Recovery and Reinvestment), relative to the acceptance of an ARRA Edward Byrne Memorial JAG award in the amount of \$30,514,178 on behalf of the 77 partner jurisdictions, for the grant period March 1, 2009, through February 28, 2013, and related actions.
- 2. INSTRUCT the CAO, in conjunction with the Police Department, to prepare recommendations for the re-allocation of up to \$1,000,000 of the \$7,051,983.50 in funding originally budgeted for the Los Angeles Regional Interoperable Communications System (LA-RICS) project to supplement the Department's on-going efforts to reduce the backlog of DNA evidence kits, including a spending plan which includes an economically balanced use of in-house resources and outside laboratories.

<u>Fiscal Impact Statement</u>: The CAO reports that taking action to accept this grant will impact the General Fund in the amount of \$2,270,657. The \$30.5 million 2009 ARRA Edward Byrne Memorial JAG will provide allocations to 77 different Los Angeles area jurisdictions. The City's grant allocation totals \$11.1 million, of which \$8.05 million is dedicated to programmatic expenditures and \$3.05 million to administrative expenses. A total of \$299,120 in budgeted funds will be provided to directly support the City's three projects associated with the Mayor's Gang Reduction Strategy. The remaining General Fund impact is associated with a total of \$1,971,537 in related costs that will not be reimbursed by the ARRA JAG ARRA grant due to the ten percent limit on administrative expenses.

CONSIDERATION OF MOTION (PERRY - ROSENDAHL) relative to weekend Museum of Contemporary Art (MOCA) shuttle service.

Recommendations for Council action:

1. AUTHORIZE the Los Angeles Department of Transportation (LADOT) to permit Veolia Transportation, Inc. the DASH Downtown Los Angeles service provider, to use one City-owned vehicle to operate the MOCA weekend shuttle service as directed by the MOCA. Dates, hours of service, term of service and the need for an additional vehicle will be determined by the MOCA but in no case will this interfere with the LADOT's operational needs to provide regular DASH service. The MOCA shuttle service will operate at no direct cost to the City. Veolia Transportation will operate the shuttle vehicle(s) for the negotiated rate of \$67.65 per bus per

revenue service hour and be paid by the MOCA. Veolia Transportation will invoice the MOCA directly for the cost of operating the service. The MOCA will pay Veolia Transportation within 30 days of the date of the invoice. Veolia Transportation will ensure sufficient insurance is in place to indemnify both the City and the MOCA for any loss that may occur.

AUTHORIZE the Department of General Services to allow the MOCA shuttle to use Lot Seven to
access the Geffen Contemporary at the MOCA with the understanding that such access will not
interfere with the operation of the lot for public or special event weekend parking.
