<u>Fiscal Impact Statement</u>: The CDD reports that there is no additional impact to the General Fund. The grant funds three positions already approved by Mayor and Council per Fiscal Year (FY) 2010-11 PAR (Council file Nos. 08-0190 and 10-1168) dated July 16, 2009. This grant does not pay for indirect costs associated with the positions. However, the department reports that it has sufficient salary savings from other grant sources to offset this need and will provide full cost recovery in the amount of \$77,461 already anticipated in FY 2010-11 Adopted Budget Revenue estimates. The recommendations are in compliance with the City's Financial Policies and will enable the department to receive \$450,000 from the State Office of Traffic Safety to finance child passenger safety education and training for community residents. The resources required to implement the traffic safety education program are comprised entirely of State grant funds.
