- 5. DIRECT the Department of General Services to report relative to the impact of the support service requirements of opening the MDC on General Services personnel.
- 6. REQUEST that the Mayor pursue legislation to enable Detention Officers to carry side-arms thereby allowing Detention Officers to transport arrestees to jail facilities.
- REFER to the Budget and Finance Committee for consideration Recommendation Nos. 4 and 5
  of the City Administrative Officer (CAO) report to Council dated December 10, 2010 (attached to
  the Public Safety Committee Report), relative to the use of civilian Detention Officers to staff the

<u>Fiscal Impact Statement</u>: The CAO reports that opening the MDC in January 2011 will cost a minimum of approximately \$971,000 in General Services and Personnel Department support services. Funding for this purpose can be transferred from the Capital Finance Administration Fund. If the decision is made to authorize hiring additional detention staff in the LAPD, this will have a General Fund impact of approximately \$1.24 million.

ADMINISTRATIVE EXEMPTION AND COMMUNICATION FROM THE BOARD OF HARBOR COMMISSIONERS (Board) relative to proposed purchase and sale agreement with the Port of Los Angeles Charter High School (POLAHS) concerning the sale of surplus Harbor Department property located at 250 West 5th Street in San Pedro.

Recommendations for Council action. SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. FIND that these actions, as described in the December 10, 2010 Board report and attached to the Council file, are exempt from the California Environmental Quality Act (CEQA) pursuant to Article II Class 2(i) of the Los Angeles City CEQA Guidelines.
- 2. FIND that the subject property located at 250 West 5th Street in San Pedro is not needed for Harbor Department purposes.
- 3. FIND that the private sale of the subject property located at 250 West 5th Street in San Pedro is in the best interest of the Harbor Department, as no other bids of offers were received pursuant to the surplus sale noticing requirements, as required under California Government Code Section 54220. The Los Angeles City Charter, and Los Angeles Administrative Code, Division 7, Article IV.
- 4. FIND that the public interest allows the private sale of the subject property located at 250 West 5th Street in San Pedro to POLAHS based on its adjacent location to the Harbor Department's Administrative Headquarters, lose proximity to international trade activities and other port-related

businesses to provide maritime educational resources for school purposes, and consistency with the Memorandum of Understanding between the Harbor Department and the State Lands Commission regarding the use of the subject property as a public charter high school.

- APPROVE the Purchase and Sale Agreement with POLAHS as substantially attached to the December 10, 2010 Board report and Council file authorizing the private sale of the subject property located at 250 West 5th Street in San Pedro to POLAHS.
- 6. INSTRUCT the Executive Director to prepare the necessary documents providing for the sale of the property located at 250 West 5th Street in San Pedro that substantially conform to the terms and conditions contained in the December 10, 2010 Board report and attached to the Council file, including but not limited to:
  - a. A grant deed
  - b. Easement Agreement
  - c. Right of First Offer
  - d. Recording the documents for an estimated net proceeds amount of \$4,122,900.48, the exact amount is subject to prorates incurred in escrow after December 1, 2010, per the terms of the Purchase and Sale Agreement as attached to the December 10, 2010 Board report and the Council file.
- 7. AUTHORIZE the Executive Director to assign the Purchase and Sale Agreement to an LLC consisting of POLAHS as the sole member, as allowed before closing of escrow upon disclosure and approval of all assignment documents by the Executive Director and submission of certification of the LLC by the California Secretary of State.
- 8. AUTHORIZE the Executive Director to execute and the Board Secretary to attest to the Purchase and Sale Agreement and Grant Deed(s) upon approval by City Council.
- 9. ADOPT Order No. 10-7067.

Fiscal Impact Statement: The Board reports that the subject property located at 250 West 5th Street in San Pedro appears on the Harbor Department's assets ledger at an acquisition cost of \$3.4 million, plus \$10.9 million for improvements, totaling \$14.3 million. Accumulated depreciation of \$1.9 million recorded to date reduces the total to a current net asset value of \$12.4 million. The proposed sale will generate \$4.1 million to be paid to the harbor Department. In doing so, the Department's Net Assets of approximately \$2,429 million will be reduced by \$8.3 million, and be reflected in the current fiscal year's income statement as an \$8.3 (\$12.4 - \$4.1) million dollar loss on the sale of assets. In addition, it is anticipated that the Harbor Department's annual expenses retaining to this site (grounds keeping, utilities and maintenance) will cease, resulting in annual operating expense savings of \$330,000.
