A Commitment to Transparency

In April of this year, the City Council approved the formation of the Ad Hoc Committee on the Proposed Downtown Stadium and Event Center.

At the June 30th meeting of the Ad Hoc Committee, a representative of the Office of the City Attorney opined that ad hoc committees of this City Council are not bound by the provisions of the Ralph M. Brown Act - the state law that guarantees the public's right to attend and participate in meetings of local legislative bodies.

The City Attorney's interpretation is startling. And while some may argue it is legal for the City Council to form ad hoc committees that have the right to waive or ignore public notice and information requirements, doing so would break faith with a public that rightly expects and deserves transparency in its government.

To the City's credit, it has adhered to the requirements of the Brown Act regarding its ad hoc committees, notwithstanding the fact that it is not required by the State law but out of respect for transparency and the desire to have adequate input from the public. However, because of the fact that the issue has been made as to whether or not there is sufficient transparency on the stadium negotiations, the City should declare that from this point forward it will make all ad hoc committees conform to the requirements of the Ralph M. Brown Act.

INSTRUCT the Chief Legislative Analyst, in consultation with the City Attorney, draft an amendment to City Council Rules, requiring that all Council committees, standing and ad hoc, be required to abide by the public notice requirements of the Brown Act.
