COMMUNICATION FROM THE CHIEF LEGISLATIVE ANALYST (CLA) relative to establishing an Office of Immigrant Affairs in the City of Los Angeles.

Recommendations for Council action:

1. REQUEST that the position authority and funding be considered during deliberation of the Fiscal Year 2013-14 Proposed Budget for two positions, Office of Immigrant Affairs Director and Assistant Director (Phase I).
2. ADOPT the Comprehensive Immigration Reform Strategy (Attachment 2) which consists of the following components: 1) improved coordination of existing City service delivery to qualifying immigrants; 2) establishing a system of partnerships with other government agencies, immigration advocates, private sector, educational and faith-based organizations, the media and research centers to assist qualifying immigrants with the immigration process; and 3) review and development of policy and legislation to continue to support the implementation of comprehensive immigration reform and seek additional resources (Phase I).
3. INSTRUCT the Community Development Department to develop a service integration plan between the FamilySource, WorkSource, YouthSource and BusinessSource System and other City departments to improve and enhance the service delivery system for the City's immigrant population (Phase II).
4. INSTRUCT the Community Development Department to reconvene Immigrant Affairs Advisory Board (Advisory Board) and recommend potential appointees for Council approval, to develop policies and guide the City in its efforts to implement the Comprehensive Immigration Reform Strategy (Phase II).
5. REQUEST the Advisory Board to work with the City Attorney and the Los Angeles Police Department to develop a strategy to protect the immigrant community from fraudulent organizations and individuals such as "notarios" (Phase II).
6. REQUEST the Human Relations Commission, the Commission on the Status of Women and the Police Commission to provide policy recommendations to better serve specifically vulnerable populations within the immigrant community (Phase II).

7. INSTRUCT the CLA to invite the University of Southern California, Center for the Study of Immigrant Integration, to present their report to Council on the economic benefits of comprehensive immigration reform which is scheduled for release in early May (Phase II).
8. INSTRUCT the CLA to continue to monitor comprehensive immigration reform and review any proposal enacted by Congress (Phase II).
