<u>Fiscal Impact Statement</u>: The City Administrative Officer reports that there is no direct financial impact on the Port that can be quantified at this time for the approval and implementation of the proposed Ordinance and change to the Administrative Code Section 10.1.1. However, according to the Port, there are significant operational and administrative efficiencies that could be realized with the expanded contracting authority that would be provided to the Executive Director as a result of the change to the Administrative Code. Many of those changes do have a fiscal impact in that they would allow the Port to eliminate a larger number of reports to the Board for routine contracts which, in turn, would allow staff (procurement, contracting, legal, and administrative) to re-direct their efforts to higher value, major projects, including revenue producing opportunities. If the proposed amendment to the Ordinance is not approved, the Port states that it could need as many as three additional positions to keep up with the potential workload increases from processing the procurement contracts separately to the Board, at an estimated personnel costs as much as \$355,000 annually to pay for salaries and benefits.

In addition, by the Mayor and Council adopting an Ordinance expanding the Executive Director's authority to contract for personal services, materials, supplies, maintenance, and operations valued at or less than \$150,000 per year for a period not-to-exceed three years with a total not-to-exceed amount of \$450,000, there is the potential for savings on the procurement of goods and services. Since the Port is bound only by the City Debt Management Policies, the City Financial Policies are not applicable. Approval of the proposed Ordinance will have no impact on the City's General Fund.

- 3. REQUEST the City Attorney to prepare and present the "Clean Up, Green Up" trust fund ordinance to deposit \$100,000 from the Liberty Foundation.

<u>Fiscal Impact Statement</u>: The DCP reports that given the work program described in its report, the estimated cost for the two year, two-phase development of the Clean Up, Green Up program is projected to be \$43,763 in Year One and \$218,948 in Year Two. The estimated staff cost is based on the pay levels in place as of September 2012. The on-going costs beyond the first two years would be determined during the development of the program and a focus of the first two years would be to identify potential funding sources (fees, fines, grants) that could be implemented to off-set the costs of maintaining the program. The Los Angeles Collaborative for Environmental Health, through the Liberty Hill Foundation, has offered an initial fund of \$100,000 to initiate work on this effort and is accounted for in the financial summary contained in the DCP report. The first year will primarily include the activities in Phase One and the second year is expected to incorporate the activities in Phase Two which includes implementation of the pilot program.

At minimum, the City will incur a \$4.6 million cost, as estimated by the City Clerk, to place this Initiative on the June 3, 2014 ballot. If the Initiative is approved, the creation of a new City Public Health Department is preliminarily expected to result in a significant unknown obligation for start-up costs and ongoing costs of \$333

million per year, at a minimum. In the first year of the Department's operation, it is unlikely the City would receive more than \$72 million in fee and grant revenue. Therefore, the potential \$261 million General Fund impact associated with the operation of the Department would likely result in increased fees and/or taxes, public health service reductions, and/or significant reductions in other City services. It should also be noted the City is currently projecting a 2014-15 General Fund deficit of \$153.4 million, with declining deficits in the following two years. This Initiative will increase the overall shortfalls the City has to address.
