<u>Fiscal Impact Statement Submitted</u>: OOF reports that since the ACE Program is proposed to be implemented on a pilot basis with the Los Angeles Police and Animal Services Departments, OOF is not in a position to estimate additional revenues to the General Fund as a result of the proposed program. The CAO states in its March 7, 2011 report that the General Fund impact associated with this new program cannot be determined at this time. The ACE Program is estimated to generate approximately \$25,000 in new revenue for 2010-11 within the City Attorney's Office. In addition, \$125,000 in full-year budgeted revenue for Animal Services Department citation enforcement is not likely to be received and will impact the General Fund. Other potential costs associated with implementation such as technology and spacing issues have not been identified and may result in a future General Fund impact.

COMMUNICATION FROM THE CITY ADMINISTRATIVE OFFICER (CAO) and ORDINANCE FIRST CONSIDERATION relative to the direct sale of a parcel located at 2210-2214 San Fernando Road to Glendale KIA.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. DETERMINE that the parcel proposed for sale located at 2210-2214 San Fernando Road is no longer required for City use and that the public interest is best served by the direct sale of the property.

- 5. INSTRUCT the GSD to complete the transactions outlined in the ordinance, and process the necessary documentation to execute the sale and deposit the proceeds into the appropriate accounts, as directed by the Los Angeles Administrative Code and as approved to form by the City Attorney.

<u>Fiscal Impact Statement</u>: The CAO reports that the proposed sale is for City-owned surplus property located at 2210-2214 San Fernando Road in Council District One to CA Auto Mart Group Inc., dba Glendale Kia for a total purchase price of \$427,000. Funds from the sale will be deposited into the Sewer Capital Fund 761. The proposed transaction is in accordance with Charter Section 385 Sale of Property, Los Angeles Administrative Code Section 7.22 and 7.27 and California Government Code Section 54220, Title 5 Local Agencies, Division 2, Article 8 Surplus Land, which establish the basic guidelines for the sale of City-owned surplus property. There is no additional impact to the General Fund.
