TRANSPORTATION COMMITTEE REPORT and RESOLUTION relative to the renewal of Temporary Preferential Parking District (TPPD) No. 38 with amendments to the boundaries and authorized restrictions.

Recommendations for Council action:

1. FIND that the parking problems that led to the establishment and renewals of TPPD No. 38 for five blocks North of Runyon Canyon Park in Council District Four still exist and that no permanent solution has been found.

TRANSPORTATION COMMITTEE REPORT and RESOLUTION relative to the establishment of Temporary Preferential Parking District (TPPD) No. 181 for Solar Drive north of Runyon Canyon Park.

Recommendations for Council action:

1. FIND that an adverse parking impact affecting fewer than six blocks exists, from which the residents deserve immediate relief, in the residential area north of Runyon Canyon Park in Council District Four.
2. ADOPT the accompanying RESOLUTION establishing TPPD No. 181 pursuant to Section 80.58.d of the Los Angeles Municipal Code (LAMC) for the residential portions of Solar Drive between Astral Drive and the dead end north of Astral Drive.
3. AUTHORIZE the use of NO PARKING ANYTIME; DISTRICT NO. 181 PERMITS EXEMPT restriction throughout TPPD No. 181.

The City will gain additional General Fund revenue from the issuance of parking citations to violators of the TPPD's parking restrictions.

HOUSING COMMITTEE REPORT relative to authorization to execute a Third Amendment to Contract No. C-118561 with Paragon Partners, Ltd., and release a Request for Proposals (RFP) for tenant relocation assistance services.

Recommendations for Council action:

1. 3. INSTRUCT the HCIDLA to report to the Housing Committee in 10 weeks on this matter.

Fiscal Impact Statement: The CAO reports that there is no impact to the General Fund. Approval of these recommendations would authorize the HCIDLA to release an RFP for Tenant Relocation Assistance Services which will be funded with budgeted fees collected from landlords for this purpose. In addition, the HCIDLA would be authorized to negotiate and execute a Third Amendment to the contract with Paragon Partners, Ltd. to provide relocation services until the RFP process is completed. The recommendations in this report are in compliance with City Financial Policies in that the full cost of these services will be paid through available special fund sources. Any subsequent funding awards and term extensions will be contingent on the availability of continuation special funding.
