**PUBLIC SAFETY COMMITTEE REPORT** relative to budget modifications and contracting authorities for the Fiscal Year (FY) 2011 Urban Areas Security Initiative (UASI) grant award.

**Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. **AUTHORIZE** the Mayor, or designee, to:
  - a. **Modify** the existing grant budget for the FY11 UASI grant by reallocating funds between projects as described in the City Administrative Officer (CAO) report to the Mayor and Council dated January 6, 2014 (attached to the Council file).
  - b. **Negotiate and execute**, on behalf of the City, a contract with a consultant to draft an RFP to solicit potential vendors to design, construct and implement a system for connecting and making interoperable four separate fire Computer-Aided Dispatch systems for a term of up to five months and a contract amount not to exceed \$100,000, subject to the approval of the City Attorney as to form and legality.
  - c. **Negotiate and execute** a contract amendment to the sub-recipient agreement with the County of Los Angeles to decrease the agreement amount by \$203,749, from \$11,814,814 to \$11,611,065, subject to the approval of the City Attorney as to form and legality.
  - d. **Negotiate and execute**, on behalf of the City of Los Angeles, a contract with a vendor to provide Tactical Hemorrhage Control training, for a term of up to five months in an amount not to exceed \$41,500, subject to the approval of the City Attorney as to form and legality.
  - e. **Negotiate and execute**, on behalf of the City, a contract with a vendor to provide for the development and implementation of a mobile application for the Los Angeles Police Department iWatch program, for a term of up to five months in an amount not to exceed \$12,000, subject to the approval of the City Attorney as to

form and legality.

- f. Negotiate and execute, on behalf of the City, a contract with the Texas A&M University through its Texas A&M Engineering Extension Service to provide Enhanced Incident Management Unified Command training for a term of up to six months for an amount of \$110,000 per course, for a total amount not to exceed \$380,907, subject to the approval of the City Attorney as to form and legality.

2. AUTHORIZE the Controller to transfer appropriations within Fund 54M, as follows:
