The total annual lease rate for 2.0180 acres is approximately \$151,350.50. The Los Angeles World Airport (LAWA) wants the City to maintain an extra 0.1068 landscape strip at the City's cost. The City will create a zero landscape strip. The \$151,350.50 would have to be included in the budget for Fiscal Year 2004-05. Funding for five or six months of this fiscal year will have to be identified. The monthly cost is \$12,612.50 per month for the ground lease. The LAWA transfers funds for the services of the LAFD at LAWA sites to the City's General Fund Receipt Account, Source Code No. 419, Quasi-External Transactions. The Lease costs would have to be transferred from this fund or the Unappropriated Balance of the General Fund to the GSD's 6030 Leasing Account.

<u>Fiscal Impact Statement</u>: The City Administrative Officer reports that approval of the proposed 50-year ground lease agreement between the Airports and the GSD will create an obligation on the General Fund for lease payments. This obligation will be partially offset by receipts from the Airport for Fire Department services provided at the LAX. Revenue to the Airport Revenue Fund will be \$12,613 per month, or a total of \$151,350 per year, for the land and improvements combined. These amounts are exclusive of Consumer Price Index-based annual adjustments as well as five-year "Fair Rental Value" rate adjustments that are provided for in the agreement.
