- 3. INSTRUCT the City Clerk to inform the abovementioned government agencies that the equipment must be claimed within 60 days from the date Council approves the request, at which time it will revert to the City's surplus equipment pool for disposal by the Department of General Services.

<u>Fiscal Impact Statement:</u> The CLA reports that the sale of the surplus equipment at a below market value price is consistent with the City's Financial Policies since discarding, recycling or transporting the equipment produces a net financial cost to the City. This below market sale will increase the General Fund by \$148.00.
