(Huizar - Greuel) that the Controller, Los Angeles Police Department and the Ethics Commission, with the assistance of the Personnel Department and the City Attorney, be requested to report on the possible overlap of responsibilities between each agency or department to investigate waste, fraud and abuse by City personnel and entities.

(Huizar - Greuel) that the Council request that the Department of Water and Power (DWP) report no later than two weeks after official release of its third party audit of the Dust Mitigation Project to the Board of Commissioners; and that the report include a status update of negotiations with the Great Basin Unified Air Pollution Control District regarding a proposed 9.3 square mile expansion of the City's dust mitigation responsibilities in the Owens Valley; etc.

The report should also touch on the feasibility of adding two additional Commissions in the San Fernando Valley area, which could be accomplished by this ordinance.
