(Huizar - Cárdenas) that the City Council authorize the Mayor's Office of Homeland Security and Public Safety to accept the Juvenile Accountability Block Grant (JABG) Fiscal Year 2007-08 grant award of up to \$204,141 from the California Corrections Standards Authority (CCSA) and to negotiate, execute and submit any other necessary agreements and documents relative to the grant award, subject to approval of the City Attorney as to form and legality; instruct the City Administrative Officer to report back with necessary actions to approve a spending plan once the JABG Fiscal Year 2007 Award is accepted; approve the resolution attached relative to grant award from CCSA for the JABG Program for the \$204,141 for July 1, 2007 through June 30, 2008, subject to the approval of the City Attorney as to form and legality; and authorize that position authority is approved for one Deputy City Attorney II (0551) in Hollenbeck Division, Gang Unit for the duration of the grant period, as approved from July 1, 2007 to June 30, 2008.
