# **Subject**

Motion - The City of Angels is blessed with a myriad of attributes that make it one of the world's truly great cities. Unfortunately, there are those among us whose behavior threatens the safety and security of the City's most precious resource - our children.

It is therefore imperative that the Los Angeles Police Department (LAPD) aggressively target those individuals who have a demonstrated predisposition toward criminal behavior particularly against children by focusing the City's enforcement efforts on parole violators who are known sex offenders, pedophiles, violent criminals and gang members.

To that end, law enforcement agencies should be encouraged to preemptively sweep locations such as nuisance bars to ensure that such venues become less user friendly locales for illegal conduct and by more strictly enforcing probation violations found near Safe Passage Zones, schools, parks and other public places frequented by children. THEREFORE MOVE that, the LAPD, in cooperation with the City Attorney's Office, County Department of Probations and California State Probation Department, develop a comprehensive database of all parole violators residing in the City of Los Angeles who are known sex offenders, pedophiles, violent criminals, and gang members; and FURTHER MOVE that the LAPD be instructed to report back to Council within sixty (60) days on the collaborative efforts of the aforementioned agencies to aggressively target parole violators whose crimes specifically impact children; and

FURTHER MOVE that LAPD's report include an analysis of the number and concentration of sex offenders, pedophiles, violent criminals and gang members located within the City.
