## Councilmember José Huizar Leads Effort to Increase the DWP Discount Offered to Income Qualified Residents

**LOS ANGELES (April 9, 2008)** – Councilmember José Huizar helped ensure at today's City Council meeting that the Los Angeles Department of Water and Power (DWP) will increase the discount to eligible income-qualified DWP customers from 15 percent to 20 percent.

The increased discount will become effective May 1, 2008. Even with the increased water and electricity rates approved today by the Council, the discount will effectively lower power bills for qualifying customers.

"My biggest concern with the DWP rates increase was for income qualifying residents or those who live on fixed incomes such as senior citizens," Huizar said. "Statistics indicate that 33 percent of the children in my district live in poverty and I do not expect their families to pay higher rates. That is why I worked out a compromise with DWP to ensure that we increased the amount of Low Income Discount Rate program from 15 percent to 20 percent for qualifying customers."

For example, the average income-qualified customer's water and power bill for 2007-08 is \$55.63 per month (without the discount). After the May 1 rate increase, the average incomequalified customer's bill would rise to \$57.24. However, with the increased discount, the average income-qualified customer will see their average monthly bill drop from \$47.28 to \$45.79.

Additionally, thanks to Councilmember Huizar's efforts, the DWP's Low Income Discount Rate program outreach will be made more accountable. As part of today's approval, the DWP will be required to evaluate how well it communicates the program to residents and to improve its effectiveness in encouraging eligible rate payers to sign up.

"Unfortunately, this program is one of the best kept secrets in town. Only 87,800 have signed up, although it is estimated that there are 253,000 more customers who are eligible for this discount program. The DWP must work harder, and in partnership, with appropriate agencies to make sure hard-to-reach customers know this assistance program is available, and to measure how effectively its outreach works."

"Income" means all income of all persons who live in the household. The income qualifying thresholds, established by the state of California and adopted by the DWP's board, range from an annual income of \$29,300 for a 1-2 person household to \$55,700 for a six-person household.
