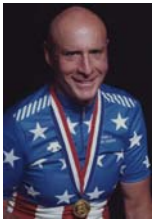

**COURSE:** Start/Finish line is on Canoga Avenue, between Oxnard Street and Califa Avenue, in front of TGI Fridays. The course is a four-corner, 0.7 mile, flat, fast loop.

**RULES:** All USA Cycling rules apply. Helmets mandatory. Bring your trainers. Absolutely no warming up in parking lots or on race course. Free lap rule in effect. Bring your own wheels - wheels in, wheels out. Prizes awarded immediately after results are official. No prizes will be given without racer's number.

**REGISTRATION:** Online registration available at [WWW.SOCALREG.COM](http://WWW.SOCALREG.COM). Bring your written pre-reg confirmation with you on race day. Online registration closes May 22 at midnight. Mail-in registration must be postmarked by May 19, 2007. After that add \$6.00. Extra races are \$7.00 each after highest race paid. All unattached riders (except for Women's 4 riders and Cat 5's) are \$5.00 extra. One day and annual licenses will be available race day for Women's 4's and Cat 5's only. Fees include \$3.00 USCF insurance. Make check payable and mail standard 2009 USCF release form to: Warner Velo, 21300 Victory Boulevard, Suite 820, Woodland Hills, CA 91367.

**LOCATION:** From the Ventura Freeway (101) North on Canoga Avenue and proceed to race course. From Simi Valley Freeway (118) South on Topanga Canyon, Left on Erwin, then right on Canoga.

**PARKING:** Available at the Warner Center Business Park on the east side of Canoga Avenue, between Califa and Oxnard. Some limited street parking is available adjacent to the course.
