Zine Combats Crime by Regulating Motel Industry Rentals

Some residential establishments, particularly motels, generate repeated calls for service and complaints of criminal activity. Some practices of these hotels & motels, such as not obtaining identification, maintaining accurate records and renting rooms by the hour, often lead to criminal activity occurring at or in the immediate vicinity of these establishments. Such practices have contributed to a variety of unlawful activities associated with the operation of these hotels & motels, particularly activities involving prostitution.

Citywide, in the San Fernando Valley, in South Los Angeles, and in Pacific Division, the problem of renting hotel rooms to engage in the crime of prostitution continues.

For this reason, Councilman Zine has introduced a motion asking the City Attorney to draft an ordinance which would amend Section 41.49 of the Municipal Code dealing with hotel registers. The ordinance would require a hotel & motel owner to 1)Maintain accurate and complete records of guests; 2)Train employees in implementation of section 41.49; 3) As to establishments that do

not provide all the services set out in Civil Code Section 1940 (b) (2): Prohibit the offering, renting or advertising of rooms by the hour or for less than 24 hours and prohibit the rental of a room more than once in a 24 hour period; 4)Prohibit guests from registering under false names and providing false identification.

Under current policy, the Zoning Administrator for the Planning Department currently imposes conditions on nuisance properties found to consistently violate LAMC 41.49 and Penal Code Section 316. Such conditions can include the prohibition of room rentals by the hour.

COUNCILMAN ZINE TAKES WARNER CENTER IN NEW DIRECTION

At Councilman Dennis P. Zine's request, the Los Angeles City Council unanimously approved a resolution to establish new procedures for new residential projects to be built in the Warner Center Specific Plan Area. Warner Center is generally bounded by De Soto Avenue to the east, the Ventura Freeway to the south, Topanga Boulevard to the west and Vanowen Street to the north.

The crux of the new procedures is that for any new multiple residential project, a "workforce housing" components of at least 25% of the units be set aside for workers that live in Warner Center and earn 120% of Los Angeles County medium income. This salary range includes hardworking professionals such as teachers, police officers, nurses and firefighters.

Also in the resolution, added

traffic mitigation measures and a project cumulative impact analysis that would study the impact of the current proposed project as it relates to existing development and future projects. Further, all new project proposals must be reviewed by the Woodland Hills, Warner Center Neighborhood Council and the community groups.

It has been made very clear to Councilman Zine that there are hard workers in Warner Center whose wages prevents them from living there. This prohibits the over-all goal of the Warner Center Specific Plan which is to create a job housing balance and a reduction of traffic congestion in the West Valley. "I envision Warner Center to be a place where people can work, live, and play with minimum reliance on a car." Councilman Zine stated. "With Westfield's new stores like Target and Neiman-Marcus and restaurants like Ruth's Chris and Marie Callenders, there is something for everybody. The jobs are also here, housing for the people that work here is the missing link."

Indeed, more than 55% of the 42,000 employees that currently work in Warner Center earn below 120% of medium income. Only 20% of the people who work in Warner Center live in this community. A number of employers indicated that the primary reason that more of their employees don't live in the area is due to afford ability.

The new measures will remain in effect until the current specific plan is amended and updated. While perhaps not formulated in the way it is now, the amended specific plan will include a provision for workforce housing along with traffic mitigation measures that have always been included in the plan.

"Red Flag Day No Parking"

Happy New Year! I hope all of you had a wonderful holiday season.

By now, most of you have noticed the "Red Flag Day No Parking" signs that have been posted south of the Boulevard. In an attempt to increase public safety, the Fire Department and Department of Transportation have created a program to remove illegally parked vehicles in posted locations within the Very High Fire Hazard Severity Zones. There is an everyday potential to create a choke point in these areas under normal situations, but during a brush fire a mass exodus could occur which could impede emergency equipment from reaching the fire area. A Red Flag Day occurs when weather conditions, defined as wind speeds of 25 mph or more and humidity 15% or less occurs. The normal range of Red Flag days per year in the past ten years was between four to seven with the greatest number in one year being twelve days. To find out if a Red Flag day has been declared citizens may call 311 and the operator will inform them if the City of Los Angeles is in a Red Flag situation. There

is a possibility that the County will be under a Red Flag warning but the City is not, if this is the case the towing policy will not be enforced, when in doubt contact your local fire department or 311 to clarify. All local news outlets have agreed to broadcast during traffic and weather segments, this includes both TV and radio. Every fire station will also fly a red flag to warn our communities.

Revitalizing Our Community

Happy New Year Everyone! Hope your holiday season was delightful and joyous! Now that a new year has begun, Councilman Dennis P. Zine and the Third Council District will continue working hard to improve the quality of life for all of our constituents.

P.A.C.E. – Pro-Active Code Enforcement Program

Reseda and a small portion of Winnetka will be undergoing a mini facelift beginning January 2006. As part of the revitalization efforts, the Los Angeles Department of Building and Safety will be enforcing municipal code regulations and requirements. A 2 mile by 2 mile area will be targeted and everything lving within Roscoe to Vanowen and Winnetka to Reseda will be inspected. This program will serve to revitalize the community and help reduce visual blight created by illegal or deteriorated conditions in business and residential areas. If code violations are found, an order to comply will be issued. However, if the problem is not corrected within the

specified time frame, a fine of up to \$1,000 or six months in jail may be imposed. Inspectors will be looking for the following:

 Merchandise for sale or display on the public way (sidewalk)

2) Illegal and excessive signage on businesses and structures (banners, walls, windows, etc.)

3) Overgrown vegetation, trash and debris

4) Illegal, unapproved use of land, structures and auto repair

5) Open storage of miscellaneous items, abandoned or inoperable autos

6) General maintenance and repair

Courtesy notices will be issued early January to all affected property owners. The Department of Building and Safety will provide the necessary contact information on this notice as well.

Zine Combats Crime by Regulating Motel Industry Rentals

There is nothing in the Municipal Code that indicates that hotel rooms cannot be rented by the hour and the imposition of conditions occurs only after a problem or nuisance case has already been established. Thus, only a small number of properties chronically plagued by criminal activity are subject to an hourly rental restriction.

Also, Section 41.49 of the Los Angeles Municipal Code requires the maintenance of registers for hotels and motels. It states that every person who owns or operates a motel shall keep a register which should contain the name and address of each guest, and the name and address of each member of his party. Each guest should also specify the make, type and license number for a vehicle in the event that this guest travels by motor vehicle. Requiring identification from persons renting rooms will discourage persons who commit crimes from utilizing these rooms for the purposes of prostitution, as these persons would prefer to remain anonymous.

Previously, in 1996, the Los Angeles City council attempted to pass an ordinance which would prohibit the rentals of hotels by the hour, but unfortunately, this issue never came before Council for a vote. The solution to preventing these hotels/motels from becoming public nuisances would be a Citywide ordinance that addresses each of these issues. Prohibiting short term rentals in the establishments that generate the most complaints and calls for service will curtail illegal activity. Councilman Zine believes that this motion is one step in the direction of eliminating prostitution and crime in these residential establishments that generate the most complaints and calls for service will curtail illegal activity

THE NEW CHARTER BUS PROGRAM

The Charter Bus Program has been changed. A new web-based Charter Bus Trip Request and Tracking System has been implemented. All request must be submitted on line, via the internet ONLY. Please follow the instructions listed below.

Group to Submit Trip Requests: Login too http://www.lacitycharterbus.com/group

Enter your Group User ID: and Password: (Call Yvette at (818) 756-8848 for this information)

Move your mouse to the Process Tab and click on Request A Trip. Enter the data required. Some entries require instruction but most are self-explanatory. Reference Number is not needed by the system, but is for the Agency or Group to use. For example, use something as simple as Trip 1 to show how many trips you have submitted.

Zip Codes **MUST** be entered to help determine if a trip is more than 85 miles. Enter any comments to clarify the trip and click the Box at the bottom of the page to indicate the Group has read and will comply with the Guidelines. Click on Next, review and correct any errors and then click Submit. A unique Trip ID Number will then be displayed for future reference.

To check the status of your trip, log on using your user ID and Password, click on the status button and select confirmation. This will show the name of your bus company if your trip has been ordered & approved. If the bus company is not listed, check back within a few days. If after 1 week, the bus company is still not listed, please call me and I will assist you.

ALL trips are now open to the public and a sign **MUST** be posted 48 hours in advance in a visible place for all of the public to see. It must state the date, time, destination, name and phone number of the contact person for your trip. If you have any open seats on your bus, anyone from the public is allowed to go on this trip. However, they will be responsible for paying any our-of-pocket expenses. Monitoring will take place to ensure all trips are posted within the allotted time frame.




