As the only program of its kind in the City, the West San Fernando Valley received a boost from the Los Angeles City Council in the form of a First Time Home buyers' Program. Funded by the Community Redevelopment Agency and administered by Los Angeles Neighborhood Housing Services (LA-NHS), the Los Angeles City Council added \$1 million to the First Time Home buyers' Program which will assist low/moderate income families in their efforts to purchase a home.

The Community Redevelopment Agency provides "silent second trust deed loans" which require no mortgage payments. These loans ensure affordability for the low/moderate income home buyers, and creates an opportunity for working families to afford a home which would otherwise be out of their price range. These loans, which

are due and payable upon sale, refinancing, or transfer of the home, have already assisted eleven new homeowners to purchase homes.

"As the only program of its kind citywide, I am thrilled to have this special incentive in my district". "Home prices are out of reach for the average family, and this program helps create a unique opportunity for home ownership. This benefits not only families but also entire neighborhoods in their efforts to become communities."

The Community Redevelopment Agency and Los Angeles Neighborhood Housing Services will be accepting new applications in 45 days. There is no waiting list at this time.

The new program which was supplemented by the

addition of \$1 million will also have an important community pride component. Two community pride days will be held in my district over the next 6 months. This will involve closing a block, and bringing in volunteers to paint the single family homes on that specific block. Prior to the day, a contracting crew will come out and prime the homes slated for painting on that day. They'll also make minor repairs to improve the homes so they look terrific once painted.

Further, free trees will be handed out on the community pride days to beautify the neighborhood and really add character. Community pride days will be a day for fun, music, food, and togetherness adding to the sense of community which will be generated by encouraging new first time home buyers. I invite you to join me in improving our communities.

PERMITTING!



Although the real estate market has been showing signs of cooling off and construction costs are at an all-time high, there is still a lot of residential building throughout the Third Council District. Ranging from a kitchen remodel or replacing windows to a new home on a vacant lot or a multi-family condo project almost every block in the district has a project going on.

With few exceptions, every project regardless of size or scope is required to have permits. Obtaining the proper permits through the Los Angeles Department of Building and Safety is not an option for a builder or a homeowner. It is mandatory. The permitting process ensures the safety of a construction proposal and makes sure that the project will adhere to the zoning code for your neighborhood.

If you are a homeowner that has not done home improvements in the past and would like to do any construction on your home the first thing you need to is go to the Building and Safety public counter located at 6262 Van Nuys Blvd on the third floor. Even if you only have a sketch or an idea of what you want to do the public counter will give you an idea of what permits you need and what type of documents you need to obtain those permits. Gaining knowledge at the public counter will help you when the time comes for choosing a building professional to do the work.





All professional builders know that it is necessary to obtain the proper permits and then build according to them. If there is a construction project going on in your neighborhood and you feel that permits were not secured or that the scope of the work is above and beyond what the permit allows, please call me at (213) 473-7003 or the Department of Building & Safety at 311. I will notify a Building and Safety inspector and request an inspection. If you wish, I will also coach you through the on-line public web-sites the city has that shows permitting records and property reports. We want to make sure that every bit of construction in Councilman Zine's district is permitted and built properly to code.

Metro Line Canoga Park Station Grand Opening

As this is the first Zine Line for the new year, I'd like to wish you all a Happy New Year and may 2007 be full of much success, health and happiness!

Within the last year, Canoga Park has experienced new growth and much anticipated development. Westfield Topanga contributed to the growth as they remodeled a large portion of the mall. During the holidays the mall was thriving and so was traffic! Well fear no longer, on December 27, 2006 elected officials, Metropolitan Transit Authority (MTA) and the community came out to celebrate the grand opening of the Canoga Park station. Now folks coming in and out of the West Valley will have the option of riding the Orange Line and stopping directly in the All America City, Canoga Park.

Councilman Dennis P. Zine along with County Supervisor Zev Yaroslavsky, Mayor Antonio Villaraigosa, Councilmember Wendy Greuel, and Roger Snobel, Metro CEO participated in the morning's press conference and ribbon cutting. They were all pleased to see the project completed and expressed much enthusiasm for promoting Los Angeles residents to ride public transportation.

Councilman Dennis Zine recalled the early days when traveling this far west was done via the Red Car or the Pacific Electric Railway. In the 1950's the tracks along Sherman Way were removed to make way for vehicular traffic. Now over 50 years later, the City of Los Angeles and MTA are looking at ways to bring back public transportation. Times have truly changed but Councilman Zine and his Third District staff remain committed to improving the quality of life for all CD3 constituents. Lastly, Councilman and the City of Los Angeles presented MTA with a proclamation for their commitment to public transportation and to the residents of this wonderful City.

The Canoga Park station is now open and includes a park and ride lot with 611 free park & ride spaces. The station itself also features artwork, pedestrian and bicycle paths and lush landscaping. For those concerned with safety, there are emergency telephones and security cameras located within the station. In the near future, MTA hopes to begin work on a six-mile extension of service from the Canoga Park station north to the MetroLink station in Chatsworth. Plans are now under review by MTA so stayed tuned for more information in the upcoming months.

TARZANA COMMUNITY AND CULTURAL CENTER BEAUTIFICATION GRANT

It is my pleasure to announce that the Tarzana Community and Cultural Center has been awarded a \$10,000 Community Beautification Grant (CB Grant) through the City of Los Angeles, Board of Public Works, Office of Community Beautification. The CB Grant is a competitive annual matching grant of up to \$10,000 awarded to community groups to fund neighborhood beautification projects.

The Tarzana Community and Cultural Center was awarded the CB Grant for the installation of an archway and the beautification of their entryway. The Tarzana Community and Cultural property is situated in the heart of Tarzana on Ventura Boulevard, thus making it an ideal location for individuals from all the surrounding neighborhoods to come together. Currently, the Tarzana Community and Cultural Center serves as a meeting location for many civic organization including Tarzana Property Owners Association, Tarzana Neighborhood Council, and Tarzana Business Improvement District.

Seeing the need to beautify the Third Council District, Councilman Zine wrote a letter of rec-

ommendation for the Tarzana Community Cultural Center to be awarded the \$10,000. Councilman Zine stated, "I believe that the Tarzana Community and Cultural Center embodies and represents the Third Council District and will continue to shape and improve the quality of life for my constituents. The installation of the archways and beautification of the entry way will attract more people to the Center, creating a vibrant hub for people of all ages in the community to gather."

CALABASAS CIVIC CENTER GROUND BREAKING

On January 6, 2007 Councilman Zine attended the City of Calabasas Civic Center Groundbreaking Ceremony. Elected officials, City staff and founders of Calabasas were all in good spirits to celebrate this historical event.

LEGISLATIVE ISSUES: AGENDAS, RESOLUTIONS, MOTIONS_

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state or federal governmental body or agency must first have been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor, and

WHEREAS, hybrid vehicles, which combine an electric motor with a gasoline-powered engine, have significantly higher fuel efficiency than vehicles with conventional engines alone, with most hybrid vehicles on the market getting more than 48 miles to the gallon; and

WHEREAS, by significantly decreasing fuel consumption, hybrid vehicles help to reduce the emission of pollutants into the environment and their use should therefore be encouraged as a more environmentally friendly alternative to the use of vehicles with conventional engines; and

WHEREAS, hybrid vehicles remain more expensive than conventional cars, and the State of California, in order to increase the demand for hybrid vehicles, has authorized the release of 75,000 Clean Air Vehicle Stickers to qualifying hybrid vehicles that allow drivers of those vehicles to use carpool lanes even when they are the sole occupant of the vehicle; and

WHEREAS, the original 75,000 Clean Air Vehicle Stickers for which the State's Vehicle provides have been issued, and as of January 1, 2007, the State will allow an additional 10,000 stickers to be issued; and

WHEREAS, government agencies are the owners of many hybrid vehicles that have been issued Clean Air Vehicle Stickers, and those issued stickers count against the current 75,000 sticker cap and will count against the increased 85,000 sticker cap in 2007; and

WHEREAS, those Clean Air Vehicle Stickers represent an important incentive that encourages consumers to purchase fuel efficient and hybrid vehicles, and counting governmentowned hybrid vehicles against the cap only hastens the point at which the cap is reached and eliminates the incentive the stickers provide to consumers,

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2007-2008 State Legislative Program SUPPORT and/or SPONSORSHIP of legislation that would exclude Clean Air Vehicle Stickers issued to government vehicles from being counted towards the statewide 85,000 sticker cap on sole occupant hybrid vehicles permitted to use carpool lange.
