## ITEM NO. (4): VACCINATIONS

Fernando Morales, representative from for Senator Ben Allen, California Senate District 26, discussed the senate bill that proposes eliminating the vaccination opt-out for families of school children.

## ITEM NO. (5): DEPARTMENT OF TRANSPORTATION'S DISABLED PARKING PLACARD POLICY.

Ken Husting, Los Angeles Department of Transportation (LADOT), provided data about parking placard use in downtown Los Angeles, in order to determine the content of a future "Disabled Parking Placard Policy."

The Commission requested LADOT to return next month. Additional meetings between DOT and DOD will be arranged and findings will be summarized for the Commission's consideration.

The Advocacy Action Group (AAG) requested the support from the Mayor and City Council for statewide efforts to increase the overall SSI amount through the State's augmentation of the State Supplemental Payment (SSP).

ITEM NO. (7): LETTER OF SUPPORT FOR ACCESS SERVICES.

Because the Commission lacked a quorum at the time of considering this item, the Commission could not vote on the motion 05062015-7 relative to the Commission on Disability approving a letter of support of Access' petition for an amendment to the federal regulations on fares.

The motion was deferred until the next meeting.

However, Access could discuss with the Department on Disability about sending out a letter of support, since the Commission could not act at this time.

# ITEM NO. (8) PROCEDURE FOR APPLYING FOR DISABLED ADULT DEPENDENT STATUS WITH FIRE AND POLICE PENSION.

#### ITEM 10: CALIFORNIA COORDINATED CARE INITIATIVE

The Commission approved motion 11052014-A relative to studying the Coordinated Care Initiative (CCI) and its impact on people with disabilities. President Bitonte distributed the letter that he signed to act upon the motion. The letter was sent to the Center of Medicare and Medicaid Services (CMS) requesting any reports generated from a CMS contract to study the state demonstration projects.

A representative from the 2015 Special Olympics passed out her business cards for future contact.

The 2015 Special Olympics World Summer Games will be held in Los Angeles from July 25<sup>th</sup> to August 2<sup>nd</sup>. The Commission on Disability requested the Department on Disability to provide an update, in order for the Commission to explore avenues of participation.

The Department is working with Olympic coordinators to ensure that all venues are accessible.

- Request to fully fund the AIDS Prevention Program and to move any proposed funds from the Unappropriated Balance to the Department on Disability's operating budget.
- Request for two positions for the ADA Compliance Division. One position will address
  emergency management and public safety. The second position will address ADA
  Compliance issues associated with sidewalk repairs, which was recently settled in the
  case of Willets v. City of Los Angeles. The priority for sidewalk repairs will be focus on
  City facilities first. Additionally, provisions are being proposed to ensure that people
  with disabilities can petition that identified non-compliant sidewalks be placed on a
  higher priority.
