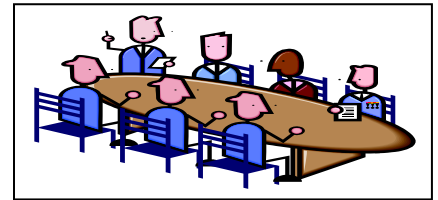
NC System Review

City Starts Clock Ticking on 912 Commission; Approves Funding

NCs Have Been Slow to Respond

The LA City Council approved a half a million dollars to fund it and the Education and Neighborhoods Committee set an April 11 deadline to define it. The clock is now ticking on the ordinance that will create a commission to review LA's Neighborhood Council system. To fulfill the requirements of the City Charter, the City Council must approve the creation of the so-called 912 Commission (a reference to Charter Section 9.12) next month.



Between now and the April 11 deadline, Chair Alex Padilla and his E & N Committee continue to urge Neighborhood Councils to provide input on the formation and perimeters of the commission. Even though the recommendations of the commission could have considerable impact on councils, they have been slow to respond. To date, only four NCs and the CityWatch NC Action Committee have offered proposals, or the results of board actions, to the committee. **See Page 8. "912 Commission"**

If NC Groups are the People's Lobby, Should They be Asked to Register?

An Ethics Commissioner told Patrick McGreevy of the LA Times that he is about to propose that "homeowner groups, union activists and some heads of non-profit organizations" should be required to register as lobbyists the same as anyone else who frequently tries to influence City Hall.



At the last NC Congress meeting, Steve Twining, President of the Bel Air Beverly Crest Neighborhood Council, said that the Congress was the neighborhood lobby against the paid and the powerful at City Hall.

The two thoughts ... the Commissioner's proposal that neighborhood organizations should register as lobbyists and Mr. Twining's idea that the NC Congress is the neighborhood lobby ... got me to thinking. Are two visions about to collide? Is it possible that NCs ... in some form ... could one day be defined as lobbyists?

The City's Labor Woes Start to Mount; Librarians Appear to be Next

If you happened to go to the library on Saturday afternoon you probably saw your local librarian outside on the sidewalk asking for your support. While most of the City's labor contracts have been signed and put to bed the Librarians Guild contract is still pending.

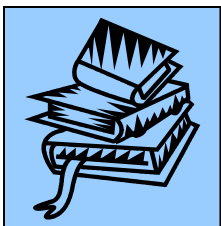


Unlike the Engineers and Architects (EAA), the problem is not about money it's about respect and reciprocity. According to Guild

President, Roy Stone, there is one outstanding issue that Librarians refuse to concede. That issue deals with a side letter the City wants to attach to the contract giving the City a "re-opener" if the city has a financial crises. In contract-speak, a re-opener gives the City the opportunity to re-open contract negotiations. Usually re-openers serve as contingencies for unforeseen occurrences.

In the case of the Librarians, the City wants the opportunity to re-open the contract upon the declaration of a financial crises so they can cut wages and benefits. The Guild would be compelled to meet with the City and if they are unable to reach a solution, the City could arbitrarily impose one. Stone calls it "a contract written in disappearing ink", since it can be changed unilaterally by the City.

Both police and firefighters have protection against the city unilaterally imposing a contract on them. The Librarians, who have been working without a contract for two years, want the same protection.



Stone noted that the Librarians are finding support amongst their patrons and will be taking their petitions to the City Council within the next couple weeks. The City's growing division with its employee unions is beginning to mount. And, it's still early in the year. *(Mark Siegel is the Founder and former Editor of CityWatch and is employed by the AFSCME36 labor union.)* ■

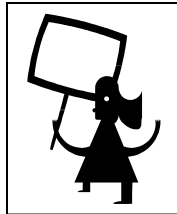

NCs Must Weigh in on 912. Now!

Has YOUR Neighborhood Council Weighed In On The 912 Commission?

What – you don't even know about the 912 Commission? Well, on April 11th the City Council's Education and Neighborhoods Committee will recommend how the people who will determine the future of Neighborhood Councils will be appointed – and unless we act now, the Neighborhood Councils may be totally excluded.



To backtrack, the City Charter calls for a commission to evaluate LA's Neighborhood Council system to convene by June 30th of this year. The first recommendation from the Chief Legislative Analyst's office called for all the commission's members to be selected by either the Mayor or the City Council. There is now, however, a second proposal from the CLA, called "Option B", in which each City Councilmember selects one person, and each Neighborhood Council will select one candidate. The NC candidates will be put into a pool and the Mayor will pick seven representatives to the commission from that pool.

Other Options

There are other options. The CityWatch Neighborhood Council Action Committee and the Coastal San Pedro Neighborhood Council have each proposed that the NC's themselves selecting one representative from each planning area for appointment to the commission. The Downtown Los Angeles NC has recommended that the NCs be allowed to directly select 25% of the commission's members. The selection to be made at DONE's June 17th Congress of Neighborhoods.

Each of these plans will ensure that the Neighborhood Councils have a direct voice on this vital commission. So which ever one your council feels is best – or if you have your own ideas – it is critical that you agendize this issue so your council can be heard BEFORE the April 11th deadline.

Appear before E & N

And even if your Council can not take a position now, you can still appear before the E & N committee's March meetings and give your personal opinions and ideas on the commission's make up and on how you think the NC system should be evaluated by the commission. (See 912 Commission timelines in this CityWatch.)

You are urged to act now. It is safe to say that the future of LA's Neighborhood Councils ... at least as we now know them ... will depend on it. (Brady Westwater is a writer and sometime contributor to CityWatch. He is also the President of the DowntownLA Neighborhood Council.) ▣

Mid-Town No Holly Split Delayed; Rug Pulled Again on WCKNC Vote

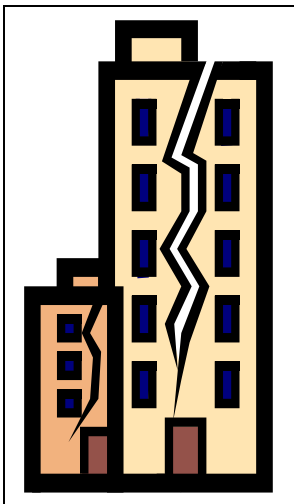
Two of LA's Neighborhood Councils tripped over the old "procedure pothole" and as a result face disappointing delays.

The **Mid-Town North Hollywood** council had their plan to downsize put in hold mode because their board meeting agenda wasn't consistent with the action the board ultimately took.

Meanwhile, for the second year in a row, the **Wilshire Center Koreatown** Neighborhood Council pulled the rug on their general election just hours ... three days to be exact ... because of election procedure violations.



Mid-Town, you will recall, voted in January to change their boundaries and downsize. The idea is that the existing NC would maintain roughly a third of their present geographical area and the remaining two thirds would be split up and two new councils would be created. Better stakeholder representation and three times the funding, for the same region, was the reasoning.



The problem: The MTNHNC bylaws provide that amending bylaws requires a two thirds board approval and that the "exact wording of the proposed change is included in the agenda of the required notice of the meeting."

Altering boundaries means changing the bylaws. Changing the bylaws requires approval from DONE and/or the Board of Neighborhood Commissioners. Someone complained about the board vote. DONE hit the memo key and told the MTNHNC board it would not be able to approve a bylaws change that violated the bylaws. Action delayed.

Rita Moreno, DONE's Sr. Project Coordinator, recommended scheduling another vote in May and also suggested that, with the importance of the issue, the Council might want to schedule a couple of well publicized public hearings on the idea of an MTNH split up.

At last report, the Council had decided to move forward with a rescheduled re-vote in May.

...

For the Wilshire Center Koreatown stakeholders, it was déjà vu all over again. A year and a half ago, the NC cancelled their election just hours from polls opening, because of a controversy over mail-in ballots and ineffective election outreach.

This year, just three days before polls were to open, Independent election Administrator, Jerry Kvasnicka, put the brakes on because "several issues ...led me to believe that the election—if held as currently planned – would be challenged and ...would most likely be overturned."

Mayor Awards \$50.6 Million For Affordable Housing Units

March 13-Mayor Antonio R. Villaraigosa today awarded \$50.6 million from the City's Affordable Housing Trust Fund to 14 projects.

The \$50.6 million-round of funding will help build 687 affordable housing units and is the largest amount committed at one time in the City's history.

\$200 million Investment

Since each dollar awarded from the trust fund leverages \$3.10 more in state and private funds, the approval represents more than a \$200 million investment in the City's affordable housing supply.

"One of my highest priorities is to increase our City's supply of affordable housing," said Mayor Villaraigosa. "And today, we're putting words into action."

According to the Mayor, at the current rate of financing, the Trust Fund will have provided and leveraged more than \$1 billion by the end of 2006. **The 14 projects awarded today:**

In addition to his Neighborhood Council efforts, Navarro, an attorney, has been a community activist for years. He sits on the boards of the Mexican American Bar Association, the LA Housing Law Project and the Silverlake Conservatory of Music.

Villaraigosa announced six other appointments to the Commission: Stephanie Klasky-Gamer, Evangeline Ordaz-Molina, Lisa Sugino, Alice Harris and William Saxe Epps. (Their bios are available on the City's website: www.lacity.org.)

Diversity Complaints or Self-flagellation

Why do some in the LANCC (LA Neighborhood Council Congress) indulge in this self-flagellation? (*"Diversity Complaints-CityWatch March 6.*)

I would think as the outreach chair of the LANCC that you might have something to contribute here. In fact, I would think you might even be insulted by the implied charge that there was little effort to diversify outreach.

The question to ask is not is the LANCC Congress represented of the diversity of Los Angeles, but is the LANCC Congress representative of the diversity of Neighborhood Councils?

Never had a Woman Mayor

The fact that some groups have reduced representation in Neighborhood Councils is only a reflection of greater citywide, and indeed national, reality. We've never had a female mayor of Los Angeles, nor a female US President for that matter and only just got our first Latino Mayor. The US Supreme Court has never had more than two female justices. Blacks have been historically underrepresented but currently fairly represented on the Court. The US Senate is a white mans preserve. The California State Assembly has over twice the number of men versus woman (55 to 25). Yet the state is roughly 50/50 in gender.

The Los Angeles City Council is the worst offender with just three females, 20% and only four Latinos (27%). White males are over represented. Sound a bit like the LANCC.

My humble suggestion: hold all LANCC Congress meetings in the most underrepresented areas of the City. In the Valley we could hold it at the Richi Valens Center in Sylmar.

This is a controversial subject that could be handled by a LANCC (sub) committee

The Ethics Commissioner, Sean Treglia, told the Times that the current rules for lobbyists are too weak. He wants to widen the net. To extend the registration requirement to anyone who is paid \$4,000 in a quarter, spends 20% of their time making direct contacts with city officials or makes at least 15 direct contacts in a quarter.



Let's accept that since Neighborhood Councils are city agencies, the Commissioner's proposal wouldn't affect them when they're acting as Charter-mandated advisory bodies. However, what of Neighborhood Councils, or board members, who form deliberative bodies or issues alliances outside of their council? Groups whose very goals are to influence City Hall. Lobby if you will. The NC Congress is an example. Are these groups now out of reach of the protective "city agency" arms? Are these, now, NC members acting as lobbyists? The kind of lobbyists that Commissioner Treglia wants to register?

I'm not offering up Treglia's proposal because its approval is eminent. Even likely. But, government works in peculiar ways. It can fashion tangents and odd-ball solutions out of the ether. Whim and circumstance have provided us with more than a few nonsensical laws. So, a deliberative NC alliance, whose goal is to influence City Hall, having to register as a lobby may not be that far fetched.

DONE GM, Greg Nelson, says such an idea ... even if it were to go forward ... has some serious hurdles to deal with. "It would likely be a violation of the Charter," Nelson says. "The purpose of Neighborhood Councils is to increase participation in government."

Then, there is of course, the First Amendment hurdle. And, most important, Nelson tells us, "It would have a serious chilling effect on councils."

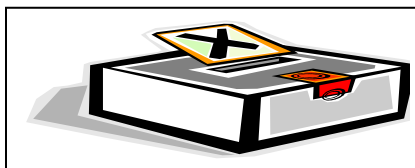
Hayden Barbarie, an attorney and a community activist, reminds: "Anybody can propose anything ... no matter how silly it is. Even an Ethics Commissioner. That doesn't mean anyone is going to take it seriously."

Still, I would remind Mr. Twining ... "we are the neighborhood lobby" ... to be careful what he wishes for. Or, at least how he phrases it. There are folks like Commissioner Treglia listening in the wings. Those "neighborhood lobby" words are music to his watchdog ears. ■



WCKNC Election Delayed Again-From Page 4

Primary among Kvasnicka's concerns were a last minute change of election venue and the selection of an unqualified Final Decision Maker. The WCKNC board voted to change the venue just six days before the election was to be held.



Separate from the Kvasnicka decision, concerns had been expressed by at least one stakeholder and former council organizer that the WCKNC board does not reflect the community, which he says is "56% Latino and 25% Anglo." The Council's governing board, he says, "is 90% Korean" and reflects an unacceptable outreach effort.

As of this writing, the WCKNC website offers no information on a future election date. ■

In an effort to get NCs energized on this issue, the City Council has asked the Department of Neighborhood Empowerment to attend Neighborhood Council meetings "to inform and solicit the participation of NCs in the drafting of the ordinance." The City is looking for NC feedback, in particular, on the method to be used in appointing the commission and of evaluating LA's Neighborhood Council system.

The City's Chief Legislative Analyst has provided two proposals to the E & N Committee. Option "B" includes direct participation by NCs in the appointment process. Neighborhood Councils can support one of the CLA's options or provide advice of their own. In any case, Community Impact Statements or for-the-record statements before the E & N Committee need to be in by April 5 to have any significant impact on the direction the ordinance will take. (NCs can find background on the 912 Commission, the Charter Section 912, the two CLA proposals and the City's timelines on the formation of the commission on the [DONE](http://www.lacityneighborhoods.com) website: www.lacityneighborhoods.com.)

The evaluation of the NC system is a requirement of the City Charter. Section 9.12 requires that the Mayor and the City Council appoint a commission to evaluate the NC system after seven years from the date the new Charter was approved by LA voters. The commission will make recommendations to the City Council which could include things like redefining what a stakeholder is, different funding criteria, etc.



The E & N Committee has been asking for NC input since last October. The limited response has been disappointing to some. As one city staffer said, "It's baffling how something with this much potential impact on Neighborhood Councils could stir so little apparent interest."

The \$500,000 funding approval for the 912 Commission starts the clock ticking for NCs. In some cases, to weigh in will require the calling of special meetings. But, as happens so often with Neighborhood Councils, there is no neutral ground. They need to be heard from because not responding also makes a statement. In this case, not a positive one. ■
