IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LA CITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE CANOGA PARK NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED VIRTUALLY.

Every person wishing to address the Board must dial 669-444-9171 and enter 886 6294 1663 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph , to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

 - b. Discussion and Possible Action: Approval of up to \$5,000.00 for a Neighborhood Purpose Grant for the Canoga Park Community Center
 - The Canoga Park Community Center is hosting its 33rd Annual Canoga Park Memorial Day Parade on Monday, May 26th, 2025. This is a signature event in the Canoga Park Community and the oldest running Memorial Day Parade in the City of Los Angeles. The requesting grant of \$5,000.00 from CPNC will augment the contributions and fees toward the funding of the \$30,000.00+ needed to operate the parade.
 - c. Discussion and Possible Action: Approval of up to \$5,000.00 for a Neighborhood Purpose Grant for Nueva Vision Community School.
 - Grant Funds will support ongoing free and affordable music programs located in Canoga Park. They offer lessons in piano, guitar, and drums. The Canoga Park Program Currently Serves 50 students who all reside in Canoga Park.
 - d. Discussion and Possible Action: Approval for up to \$5,000.00 for a Neighborhood Purpose Grant for Meals in Motion.
 - Grant award will be used in program support of our PALS and Pans and Family Night Cooking Class events. Our cooking classes provide lasting skills and knowledge in the fight against food insecurity, while providing a safe space to build family bonds and create environments for youth to thrive and grow. The support will help to expand our impact and further solidify this resource to youth and families for the upcoming year in the Canoga Park Community. Funds will be used to purchase food, materials and equipment for our free cooking events.
 - e. Discussion and Possible Action: Approval of up to \$1,100.00 for a Neighborhood Purpose Grant for the Foundation for the Preservation of the Santa Susana Mountains.
 - As part of the LAUSD curriculum, 3rd graders study California History and Native American culture. These Hikes have Interpretive stops along the two mile hike route where the students learn about the life of a Chumash Indian child from a storyteller from the local Indian tribe. At another Educational Stop there is a life-sized model of a Concord stagecoach, where they are taught about travel before the railroad came through. A third stop is at the quarry that provided rock for the San Pedro Harbor breakwater and ornamental stone for many of Los Angeles's downtown buildings. A teacher from the Audubon Society, with an array of bird exhibits teaches them about our local bird population at a fourth stop.
