The Central San Pedro Neighborhood Council appreciates the Port of Los Angeles' commitment to update all the Harbor Area neighborhood councils at it monthly Neighborhood Council and Chamber Presidents meetings wherein current Port issues are discussed. For the Central San Pedro Neighborhood Council, the information that is disseminated at these meeting is of vital concern due the fact that most of the Port complex is located within Central's boundaries. Issues arising from the Port's meetings critically inform Port Committee actions that are then taken up by the entire Central Council in the face of serious time constraints.

Cancellation of two of the last three Neighborhood and Chamber meetings, indeed any of the monthly meetings, deprives the Harbor Area neighborhood councils of current information on Port issues and events.

Without the facts, the Central Council and its Port Committee cannot make factual, appropriate or reasoned comments that reasonably inform our stakeholders.

To remedy the situation resulting from the canceled meetings, we strongly urge the Port to reconsider cancelling the monthly meetings unless there is a critical reason (s) for doing so. Further, if a meeting is cancelled, we request that the Port provide a detailed and comprehensive list of that months salient issues that could be taken up by the council and its committees. Additionally, the Port should increase its outreach to all the Harbor Area neighborhood councils and chamber presidents, urging that each council have two regular representatives (nc president and guest) and a dedicated alternate. The Port should solicit the names of attendees in advance of the meeting. Finally, we request that the Port begin

recording the meetings, and secondly seek relevant agenda items from each neighborhood council a week prior to the scheduled monthly meeting. Thank you for your attention to these concerns.

b. Motion to support the Mexican Hollywood square designation markers.

Whereas the preservation of history of San Pedro is valuable to the community at large and that the history of the Latino contributions have often been overlooked. We find that support the recognition of Mexican Hollywood and its culture is a significant part of the historic fabric of this community. Therefore we urge both the Port of LA and the City of LA to support and adopt Mexican Hollywood as a cultural landmark and recognize its status within the greater Los Angeles area.

Therefore we are asking the Port of LA to release any and all San Pedro Bay water quality reports and to present them to Central San Pedro Neighborhood Council at one of our general meetings within 90 days of the passage of this motion.
