PUBLIC COMMENT AT NEIGHBORHOOD COUNCIL MEETINGS AND COMMITTEE MEETINGS -The public is requested to dial *9, dial *6 to unmute yourself, when prompted by the presiding officer, to address the Board or committee, on any agenda item before the Board or committee, takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Board.
