- A. Land Use & Equestrian Committee Committee update.
 - Motion: To support a micro distillery at 9906 Canoga Ave., with on-site tasting in conjunction with an 1,100 sq. ft. existing space; with 4 seats inside; with the hours of 10:00 AM to 8:00 PM daily in the CM-1 zone, ZA-2023-0265-CU-CUB. Wholesale and appointment only. Discussion and vote.
 - 2 Motion: To support a proposal for a revised campus plan to permit the construction/addition of two new buildings, the re-location of and upgrades to existing athletic facilities, and the reconfiguration of existing on-site parking resulting in a total of 243 parking spaces at 19800 Devonshire, 10210 Oakdale Chaminade College Preparatory Middle School ZA-2022-7496-CPC-1997-CU-408. The CNC's support for project will ask for consideration of enhancing north facing elevation of science building facing Devonshire, retaining 9 more trees and an alternative to 4 acres of artificial turf. These conditions do not negate CNC's support for the project.
