This grant will be used to raise awareness on the importance of mental health. The grant will be used to offer resources to their next wave of leaders.

4. Discussion and possible motion to approve a NPG in the amount of \$5,000.00 for Granada Hills Charter High School located at 10535 Zelzah Ave., Granada Hills, CA. 91344. This grant will help the Robodox’s mission of spreading the knowledge of STEM and grow our initiatives within Chatsworth.
