

#### 3. New Business

- A. Motion to approve a Neighborhood Purpose Grant (NPG) in the amount up to \$4,116 for the *Foundation for the Preservation of the Santa Susana Mountains*. This grant will fund two (2) Chatsworth Elementary 3rd grade students (Germain and Superior St.) hikes. Approximately 150 students will participate in two LAUSD-approved field days in the Santa Susana State Historic Park during the 2023-2024 school year. The funds will be used for the rental of 2 school buses, portable sanitation unit rentals, and stipends for the Native American storytellers for each of these hikes.
- B. Motion to approve a Neighborhood Purpose Grant (NPG) in the amount of up to \$500 for the art program at Lawrence Middle School for this semester. The funds will go to organizing the events and providing materials and supplies.

Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period: however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Board.
