

#### 4. New Business

- A. Request for \$5,000 Neighborhood Purpose Grant (NPG) for SOLID, a voluntary organization serving Devonshire LAPD Station. The Force Option Simulator (FOS) Trailer at Devonshire Police Station is no longer needed for its original purpose of training officers. The \$5,000-grant NPG would help SOLID renovate and furnish this area for the purpose of providing a meeting room for volunteers serving the Station.
- B. Come up with a plan to inform the neighbors that they are responsible for their parkway a notice made and a way to distribute to the neighbors that are the offenders.
- C. Some bridle trails of Chatsworth are not maintained. Some of these include thigh-high weeds running from Chatsworth to Rnaldi along Canoga and along Chatsworth to Variel Streets. Additionally, there are other areas which need addressing safety issues. Contact the CD12 to take care of these issues.

Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Board.
