# Homelessness Awareness, Public Safety & Transportation — Committee update, Paul LaBella



This is to inform you of a motion to censure you on behalf of the Chatsworth Neighborhood Council Board Members at a hearing to be held on December 3, 2025, at Lawrence Middle School ,10100 Variel, Chatsworth, CA 91311, at 6:30pm during a regular or special Board meeting.

- At the September 24<sup>th</sup> Public Safety & Transportation Committee(PS&T) meeting, it is alleged that you were "fixated on President, Kristen Shubert and the Beautification and Outreach Committee's event Rocktober" for the first portion of the meeting that was not agendized; it is alleged that you were "angry" and "not receptive to comments" from your committee members. It is alleged that you "were asked to follow the agenda items but was rude and dismissed our recommendations." Another member said, "I would like to censure Shawn Sangeladji based on the emotional dysregulation and inability to control anger management that I witnessed on September 24<sup>th</sup> at the PS&T committee meeting....Shawn does not follow the code of conduct." He also states, "Shawn uses his time as committee chairman to question the legitimacy of democratically approved events such as Rocktober and also questions the authority and integrity of democratically elected leader of the CNC." Another member wishing to censure states, "During that discussion, Shawn went on berating Kristen at length. After about 20 minutes of this non-stop haranguing about Kristen, the committee members unanimously suggested that Shawn and Secretary, Paul LaBella, should have a dialogue with Kristen. Unfortunately, that never happened." These are violations of the CNC Bylaws Article XIV Compliance, Section 1: Code of Civility -" The Council, its representatives, and all stakeholders will endeavor to conduct Council business in a professional and respectful manner. Board members will abide by the Commission's Neighborhood Council Board Member Code of Conduct Policy." It is also an infraction of the Chatsworth Neighborhood Council Code of Conduct that states,"#4. Members shall not use language that is threatening, obscene, or slanderous, including profanities, insults or other disparaging remarks or gestures directed toward any CNC Board Members or Committee Members." This is also a violation of the Brown Act 549542, ... "no action or discussion shall be undertaken on any item not appearing on the posted agenda."
- "I am compelled to share my concerns with the current chairperson of the PS&T committee, Shawn Sangeladji. During the last meeting I attended, the Chairperson, Shawn, was outwardly upset with Kristen Shubert, President, and her leadership of the CNC. He claimed that conflicting

CNC event dates on the same date-Rocktober and Coffee with a Cop-were not discussed with him and/or the PS/T committee." (The Rocktober event was a discussion in May, 2025, at the Outreach Committee meeting. It was on the agenda after that meeting and voted to be an event with a budget in July at the Outreach Committee meeting. Rocktober was a motion at the August Board Meeting that passed.) Coffee with a Cop never had a motion put forward by Shawn for the Board to vote on it; it was NOT an Event as Jose Galdamez informed Shawn at the August CNC Board Meeting. "Shawn displayed what I consider an inappropriate amount of anger towards Kristen and believed Kristen had lied to him. Shawn's anger was quite evident, and I believe he took up an inordinate amount of committee time sharing his anger with the committee, rather than contacting Kristen directly to address his concerns. He was encouraging the committee to confront Kristen as a group. This was not acceptable to me." These behaviors are against the CNC Bylaws, Article II, subsection C,4,"Policy of the neighborhood council shall be: #4. to encourage all community stakeholders to participate in the activities of this Neighborhood council." This is also a violation of the CNC Bylaws Article XIV, Section 1: Code of Civility -" The Council, its representatives, and all stakeholders will endeavor to conduct Council business in a professional and respectful manner. Board members will abide by the Commission's Neighborhood Council Board Member Code of Conduct Policy." This is also a violation of the Brown Act 549542, ..."no action or discussion shall be undertaken on any item not appearing on the posted agenda."

- Regarding the September 24<sup>th</sup> PS&T Committee meeting, a member of the committee stated,"I do not feel safe in his presence. I left the meeting(early) feeling very stressed and concerned about our safety." This committee member resigned because of her feelings. This is an alleged infraction of the "CNC Board Rules Code of Conduct, #6,"Board Members and committee members shall not be engaged in 'bullying' or 'harassment,' which are generally defined as follows: 'Bullying' and 'harassment' are conduct that meets all of the following criteria: a. Is reasonably perceived as being dehumanizing, intimidating, hostile, threatening, or otherwise likely to evoke fear of physical harm and/or emotional distress."... And" e. Adversely affects the ability of a member to participate in or benefit from the CNC program or activities by placing the Member in alleged violation reasonable fear of physical harm or by causing emotional distress...'
- At the September 24<sup>th</sup> PS&T committee meeting, a committee member alleges, "He also did not assist with public safety and transportation issues, such as car racing on Lassen Street, pavement issues in an alley, and safety concerns of the Andora St. residents." In addition, Tracey Jennings asked Shawn why he did not include any of her agenda suggestions for the October 22nd meeting. The allegation is that Shawn became very angry when questioned. He placed his hand under his chin to mock listening to Tracey. She commented that she felt uncomfortable with that stance, then Shawn asked PS&T Secretary, Paul LABella, to make a note in the Meeting Minutes. He was very dismissive and rude in regard to any of her agenda questions. The CNC Board Rules state, "Meeting Preparation Basics, C. Agendas, 3.Placing items on the agenda-An item may be considered for placement on the agenda in any of the following ways: a. By request of a board member or committee member." This is also an infraction of the "CNC Board Rules Code of Conduct, #6,"Board Members and committee members shall not be engaged in 'bullying' or 'harassment,' which are generally defined as follows: 'Bullying' and 'harassment' are conduct that meets all of the following criteria: a. Is reasonably perceived as being dehumanizing, intimidating, hostile, threatening, or otherwise likely to evoke fear of physical harm and/or emotional distress."
- It is alleged, at the August 27th meeting of the PS&T Committee, a committee vote was taken to
  have Coffee with a Cop on the same day as Rocktober on October 25th. Shawn, Chairman of PS&T
  reported that committee vote was unanimous, however it was not. A committee member
  objected and was not recognized. It is alleged at the same meeting that Shawn submitted the

motion to the Board agenda for the purchase of his CNC business cards, but did not have a committee vote, and reported no committee vote. This is a violation of the CNC bylaws, Article II, Purpose, C.#6,"The policy of neighborhood council shall be: To have fair, open, and transparent procedures for the conduct of our neighborhood Council business. It is also a violation of the CNC Board Rules: Voting, Motions, & Discussions, H. Voting,#7:"The presiding officer or designee shall announce the result of the vote."... And, Motions,#6, "Committee motions submitted to the Board shall include the vote count of the committee."

- It is alleged at the PS&T October 22<sup>nd</sup> meeting that Chairman Shawn Sangeladji used the "Public Comments" agenda item to falsely accuse President Kristen Shubert and Treasurer Tracey Jennings of covering up purchases made for Rocktober. In an extremely aggressive manner, he continued to falsely claim that he had a \$1,000.00 receipt from Lowe's and he could prove" that the purchase for paint was made by Kristen and he had the receipt to prove it." Members of PS&T asked to see the receipt, which he refused to produce. He continued to berate Kristen and Tracey and the Beautification and Outreach committees, regarding Rocktober expenses being falsified in his opinion. During this tirade that had nothing to do with public safety or Public Comment, he instructed Paul Labella, the Secretary, to note in the meeting minutes that he felt retaliated against and to add his comments to the Meeting Minutes. He continued to talk over committee members, members of the public, and interrupt Tracey when she tried to coach him on the event process from a Treasury Standpoint. This is a violation of the Brown Act 549542, ..."no action or discussion shall be undertaken on any item not appearing on the posted agenda. This is a violation of the CNC bylaws, Article II, Purpose, C.#6,"The policy of neighborhood council shall be: To have fair, open, and transparent procedures for the conduct of our neighborhood Council business."
- It is alleged that PS&T Chairperson Shawn Sangeladji held an invalid meeting on September" 22nd; the agenda was not submitted or posted within the Brown Act guidelines of 72 hours. When he was notified of this, he chose to hold the meeting without informing the PS&T committee that it was an invalid meeting. They attended unaware it was invalid. This is a violation of the Brown Act, subsection IV, 1A," At least 72 hours prior to a regular meeting, the body must post an agenda containing a brief general description of each item to be discussed or transacted at the meeting, including items to be discussed in closed session." Also, a violation of Government code 54954.2a," At least 72 hours prior to a regular meeting, the body must post an agenda containing a brief general description of each item to be discussed or transacted at the meeting, including items to be discussed in closed session." And a violation of the CNC Board Rules, Meeting Preparation Basics, Meeting Types, Formation, Protocols, D.#4," The agenda for regular meetings and committee shall be posted in the specified locations at least 72 hours before the meeting."

Multiple Board Members and Executive Committee members contributed to this censure motion, some of their comments are paraphrased herein. You will have a reasonable opportunity to be heard at the December third Board Meeting either orally or in writing, prior to the Board's vote on this motion to censure.
