- iii) Update on DOTH. Richard Medrano organized a walk-through of Stoney Point Ranch with the property manager, Angel, and the Outreach Committee. John Lee's office has approved 50 tables, 125 chairs, three port-o-potties, and two shuttles. Flyer is circulating. This is an all-hands-on-deck for **April 18th, 2026**. The start time is 11:00am, wrapping up at 2:00pm. We will also be setting up the day before at Stoney Point Ranch.
