- a) Discussion and possible motion to request the city clerk funding office to roll over up to \$10,000 of ECSWANDC unspent funds from FY2023-2024 to FY2024-2025.
- b) Discussion and possible motion to approve Wendy Moore Business Results invoices from March 2024 in the amount of \$330.48, April 2024 in the amount of \$421.60, and May 2024 in the amount of \$546.62.
- c) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to Youth Mentoring Connection, Application.
Youth Mentoring Connection, (YMC) is requesting funding to purchase equipment for the YMC Urban Oasis Film Academy (UOFA). YMC has been providing the Urban Oasis Film Academy (UOFA) program since 2007. Funds will be used to purchase much needed equipment. Programming includes workshops on all aspects of film making including scriptwriting, storyboarding, acting, filming, and editing. The creative process and production are youth-led which not only empowers them but also brings a deeper awareness of their inner selves through their films.
- d) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to Concrete Queenz, Application.
Concrete Queenz is a nonprofit that brings skateboarding and community to underserved girls in South LA. We believe that skateboarding can be a powerful tool for empowering girls to be strong, independent, and confident. Our mission is to create a safe and inclusive space for girls to learn and practice skateboarding, while also building valuable life skills such as leadership, teamwork, and communication. Studies in the Journal of Sport & Exercise Psychology found that

participation in physical activities that foster resilience, such as skateboarding, can reduce stress that leads to those mental health problems among youth.

- e) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to New Direction Community Programs, Application.
The purpose and intent of the grant is to enhance the operation and effectiveness of our Compassion Access Center in providing social service assistance to the homeless and food insecure populations year-round.
- f) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to What's Good Neighborhood Development, Application.
This grant will be used in the following ways:
 - 1. Support of our Monthly Feed the Community Days where we provide hot meals to the community and activities to the community. These events are designed to engage the community by providing meals and entertainment at a marginal cost. (Juneteenth Community Day, Labor of Love (Labor Day Cookout)*
 - 2. The Entrepreneurial Incubator Program allows aspiring restaurateurs & caterers to use our event and market space to host pop-up events and sell products on a consignment basis.*
 - 3. The Youth Mentorship and Internship Program engages the youth in athletic, academic, philanthropic, and technical development. The program is geared to help youth achieve success through structured programming. We sponsor youth teams and organizations to help them reach organizational goals. (Summer of Learning - Youth Skills Development Program)*
- g) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to Black Being, Application.
Black Being is a Los Angeles area nonprofit organization that prioritizes the social, mental, and emotional healing of Black people as an embodied declaration of our inherent worthiness. This grant aims to support the continuation of a weekly meditation class open to all, free of charge. The Weekly Meditation space serves as a sanctuary for 25-50 community members weekly, offering mindfulness and meditation practices aimed at alleviating stress and anxiety, addressing mental health concerns, and nurturing a sense of community and belonging among participants. Grant funds will be utilized for teacher compensation and the upkeep of the space to ensure its continued operation and accessibility
- h) Discussion and possible motion to approve Neighborhood Purpose Grant up to \$5,000.00 to KRST, Application.
The purpose and intent of this application is to attain financial support to supplement the cost of running the ongoing KRST Unity Food Give-Away Program located at 7825 S. Western Avenue, Los Angeles, CA 90047. The Food Give-Away program is open and free to the general public, and supports 75 - 90 stakeholders weekly, in the Southwest community. KRST Unity has been operating this program consistently for the past four years, without incident and without support from outside sponsors or grants. Despite the lack of funding, we have consistently delivered high quality packaged goods and fresh foods to the community and the community has received us well with open arms, often expressing their sincerest gratitude and appreciation for our timeless work.
