- Discussion and possible motion to approve [Neighborhood Purpose Grant up to \\$5,000.00 to Youth Mentoring Connection, Application](#). Youth Mentoring Connection, (YMC) is requesting funding to purchase equipment for the YMC Urban Oasis Film Academy (UOFA). YMC has been providing the Urban Oasis Film Academy (UOFA) program since 2007. Funds will be used to purchase much needed equipment. Programming includes workshops on all aspects of film making including scriptwriting, storyboarding, acting, filming, and editing. The creative process and production are youth-led which not only empowers them but also brings a deeper awareness of their inner selves through their films.

Concrete Queenz is a nonprofit that brings skateboarding and community to underserved girls in South LA. We believe that skateboarding can be a powerful tool for empowering girls to be strong, independent, and confident. Our mission is to create a safe and inclusive space for girls to learn and practice skateboarding, while also building valuable life skills such as leadership, teamwork, and communication. Studies in the Journal of Sport & Exercise Psychology found that participation in physical activities that foster resilience, such as skateboarding, can reduce stress that leads to those mental health problems among youth.

*\*\*The Education Committee focuses on addressing educational issues and opportunities within the ECSWANDC area. It collaborates with schools, parents, and community members to support educational programs, advocate for resources, and recommend initiatives to the Board that enhance learning and development in the community.\*\**

Unhoused/Homeless:

*\*\*The Unhoused/Homeless Committee addresses issues related to homelessness within the ECSWANDC area. It collaborates with local organizations, advocates for resources, and develops initiatives to support and provide services for the unhoused community. The committee makes recommendations to the Board on actions and policies to alleviate homelessness and improve living conditions.\*\**

*\*\*The Neighborhood Committee works to enhance the quality of life within the ECSWANDC area. It addresses community concerns, promotes neighborhood engagement, and fosters a sense of community. The committee makes recommendations to the Board on initiatives and actions to improve safety, beautification, and community relations.\*\**

- **Council File 24-1200-S28**, Estuardo Mazariegos / House LA Citizens Oversight Committee / Commission Appointment (Mayor): Introduced June 24, 2024 and referred to Housing and Homelessness Committee. Mayor report is relative to the appointment of Mr. Estuardo Mazariegos to the House LA Citizens Oversight Committee, for the term ending June 30, 2026.

- **Council File 24-1200-S29**, Marianne King / Community Forest Advisory Committee / Commission Appointment (Mayor): Introduced June 26, 2024 and referred to Energy and Environment Committee. Mayor report is relative to the appointment of Ms. Marianne King to the Community Forest Advisory Committee.

- **Council File 23-1027-S3**, Charter Reform / Biennial Budget Cycle / Public Participation / Engagement Strategies (Blumenfield – Hernandez - Padilla): Introduced June 25, 2024 and referred to Budget, Finance and Innovation Committee.

Motion is instructing the City Administrative Officer (CAO), with assistance from the Department of Public Works, Controller, City Clerk, Chief Legislative Analyst (CLA), and other relevant departments, to report within 90 days with an analysis of potential impacts from switching to a 2-year (biennial) budget cycle, as well as provide recommendations for a biennial budget schedule and proposed timeline with due dates and milestones that would strengthen public participation.

- **Council File 23-0002-S143**, Ellis Act Amendment / One-Year Extension / Intended Future Use / Tenant One-Year Extensions / Municipality Rent Regulation (Raman – Soto-Martinez): Introduced June 26, 2024 and referred to Rules, Elections and

Intergovernmental Relations Committee. Committee waived consideration of item. City Clerk scheduled item for Council on July 2, 2024. Resolution is requesting that the City of Los Angeles include in its 2023-2024 State Legislative Program SUPPORT for legislation that would amend the Ellis Act.

- **Council File 23-0002-S144**, SB 960 (Wiener) / Caltrans Transportation Projects / Complete Street Facilities / Safe Streets / Bicycle Lanes / Accessible Sidewalks (Raman – Soto-Martinez): Introduced June 26, 2024 and referred to Rules, Elections and Intergovernmental Relations Committee. Resolution is requesting that the City of Los Angeles include in its 2023-24 State Legislative Program SUPPORT for SB 960 (Wiener), which seeks to ensure all transportation projects funded or overseen by Caltrans provide complete street facilities, IF AMENDED to remove the phrase “to the extent feasible.”

- **Council File 23-0002-S145**, H.R. 8606 (Carter) / Never Again Education Reauthorization and Study Act of 2024 / U.S. Holocaust Memorial Museum Director (Lee - Blumenfeld): Introduced June 28, 2024 and referred to Rules, Elections and Intergovernmental Relations Committee. Resolution is requesting that the City of Los Angeles include in its 2023-2024 Federal Legislative Program SUPPORT for H.R. 8606 (Carter), the Never Again Education Reauthorization and Study Act of 2024, which would reauthorize the appropriation of \$2,000,000 each year from 2026 through 2030 for the Director of the United States Holocaust Memorial Museum to support Holocaust education programs.
