 - b. **Motion (Ravi Sankaran / Green Committee)** – The DRNC supports CF 15-0719-S26 which would create a Mobility Plan Implementation Ordinance to require the City to implement projects listed on the Mobility Plan 2035 whenever substantial improvements are made to an impacted street. In 2021, 294 people were killed in traffic-related deaths on LA streets including 132 pedestrians. The City must prioritize Mobility Plan projects in order to improve mobility options and reduce traffic-related fatalities.
