 - **b.** Motion (Pooja Bhagat / Land Use Committee) The Del Rey NC supports studying circulation safety at Griffith park including SAFE's recommended proposals to implementing strategies for bike, pedestrian, equestrian circulation safety at Griffith Park (a city-wide resource) as a priority and requests the Dept of Rec and Parks to collaborate with relevant City Departments to take immediate initiatives and priorities projects in support of safe circulation.

Whereas the City of Los Angeles has held in person hearings for City Council since June of 2021, and the public has been welcome in person since May 2022;

Whereas other government involved or sponsored events have resumed in person, including CicLaVia, LAUSD School Board and Booster Club meetings and many others;

Whereas the Department of Neighborhood Empowerment (DONE) has not to date even introduced a timeline for meeting in person;

Whereas the choices of individual Councils could still be respected while DONE continues to outline hybrid meeting options;

Whereas in person interaction amongst both board members and the public is in many cases critical to the proper functioning of local government and especially at the hyper-local level;
