The Draft environmental impact report is available for review and response beginning September 9, 2022. Responses to the document are due by October 24, 2022.

f. Motion (Ravi Sankaran) – Whereas there are currently no mandates from the CDC, State or County precluding in person gatherings;

Whereas AB 361 that allows remote meetings does not mandate that they be remote, but allows for a mechanism should government bodies choose to meet remotely;

Whereas AB 2449 will require starting January 1, 2023 that at least a quorum of members of a local legislative body participate in person from a single, physical, public location clearly identified on the agenda and within the local agency's jurisdiction;

Whereas the City of Los Angeles has held in person hearings for City Council since June of 2021, and the public has been welcome in person since May 2022;
