- e. Motion (Ravi Sankaran / Green Committee) The DRNC Green Committee supports CF 22-1466 to require immediate reporting on the safety risks of the Playa del Rey Gas Storage facility and potential impacts to the community in the event of a leak. In 2015 the largest and most environmentally-damaging methane leak in US history occurred at the Aliso Canyon gas storage facility operated by SoCal Gas Company. If a similar leak were to occur at the Playa del Rey facility it would directly impact the Del Rey and surrounding community and therefore the risks, impacts, and safety plans need to be thoroughly evaluated. For comparison, the Aliso Canyon leak directly impacted a 5-mile radius of roughly 27,000 residents whereas the Playa del Rey facility's 5-mile radius would impact close to 500,000 residents. The DRNC also implores the City Council to work with State authorities to consider the appropriate timing for decommissioning the facility in light of the safety evaluation.
- f. Motion (Ravi Sankaran / Green Committee) The DRNC Green Committee supports CF 22-1402 which would require a Municipal Greenhouse Gas Emissions Inventory to be developed and maintained. As Californians, we are at ground zero of the climate crisis, enduring heatwaves and their accompanying unbreathable air, wildfires, and coastal soil erosion which has already shut down our south coast rail line. We need to take action fast and cannot do so without data to know our efforts are working. If we are to achieve citywide carbon neutrality by 2045, and municipal operations neutrality by 2035, we need accurate data to ensure that we are getting there. Therefore the Del Rey Neighborhood Council supports this motion.

- Motion (Matt Wersinger / WRAC) The DRNC supports the following position in regards to the recent adoption of Ordinance 187427 regarding speed limit reductions:
  - i. Supports the action taken by the LA City Council on March 7, 2022 in passing Council File 21-1223 regarding Speed Limit Reductions.
  - ii. Supports the efforts to reduce the speed limit by 5 MPH on streets that were recently identified for 5 MPH speed limit increases. (See the attached Ordinance number 187427 with the complete list of streets effected.)
  - iii. Moving forward, it is the suggestion of the DRNC that City Council open a Council File to consider that future speed limit reductions be discussed and planned as neighborhood or regional traffic improvements rather than individual street improvements. These improvements should be coupled with measures to minimize vehicle traffic being redirected onto adjacent neighborhood streets. For example, we would like to see LADOT incorporate traffic calming measures and active transportation elements. Traffic calming measures might include compact traffic circles/mini roundabouts, restricted turns, curb extensions/bulb-outs, speed humps and tables, and diagonal diverters, half closures, full closures, and median barriers to reduce cut-through traffic.
  - iv. Requests that the Council Offices engage the local Westside Councils in ongoing discussions about what additional streets should be considered for speed limit reductions as well as establish a method whereby Council and stakeholder feedback on this issue can be submitted directly to LADOT.
